This item is for the approval of the approval of the award of bid to Kamminga & Roodvoets, Inc. for Indian Rocks Road Phase 2B from Kent Drive to 8th Avenue SW Sidewalk and Drainage Improvements 002232A.

- The Indian Rocks Road Sidewalk & ADA Improvements from Kent Drive to North of 8th Ave. SW Phase 2B Project 002232A is for the installation of sidewalk connectivity along the East side of Indian Rocks Road, the installation of a 8' stabilized shoulder, and a mast arms section.
- A total of fours bids were received on this project from: Kamminga & Roodvoets, Inc. (\$5,616,644.00), BURGESS CIVIL, LLC (\$5,873,786.50), David Nelson Construction Co (\$6,857,548.00), and Cathcart Construction Company Florida, LLC (\$7,949,951.00). Recommended award is to the lowest and most responsive bidder, Kamminga & Roodvoets, Inc. The department and the engineer of record have deemed this bid to be mathematically and materially sound.
- The total of the Construction Agreement is a not to exceed amount of \$5,616,644.00. The duration
  of this contract is 540 days. Work on this project will commence following the contractor's receipt of
  a Notice to Proceed (NTP) from the County.
- As satisfactory progress on the project is made, the County agrees to issue partial payments to Kamminga & Roodvoets, Inc. The County reserves the right to request proof of progress made before issuing any payment.

Funding is reflected in the Amended FY25 Capital Budget, budgeted under the Indian Rocks Road Sidewalk & ADA Improvements from Kent Drive to North of 8th Ave. SW Phase 2B (002232A), funded by the Local Infrastructure Sales Surtax (Penny for Pinellas). Total available funding is the amount of the project allocation as represented in the FY25 approved Capital Improvements Program. Available funding in excess of the recommended not-to-exceed amount is available for other project costs. In the event that future fiscal year funding is not available for this project, the County maintains the authority to terminate this agreement.
