Many of your fellow Pinellas County Residents are very upset and annoyed about their “single family resident” neighborhoods being invaded, degraded and ruined by short term rentals.

I have lived in Pinellas County since 1979 and my wife of 45 years has lived here since 1969. We have lived in the same house in unincorporated Seminole for the past 38 years and we have raised our family in that house. Many of our neighbors and friends throughout the county are also long-term residents as well.

Since the invasion of the short-term rentals, our lives have been disrupted in multiple ways. Within a 7-minute walk, there are at least 8 short term rentals and one single family resident converted to a duplex. So far in our neighborhood there have been many loud drunken parties, the air smells of marijuana from the parties, a minor accident between a short term renter (2 doors from our home) at a party caused a neighbor to pull a gun, the streets are partially blocked (last night a ¾ T truck pulling a 20’ construction trailer with ladders parked the wrong way and blocked one lane of the two lane narrow street etc.), garbage cans are left out for days etc.

Our neighborhood, like many others, used to be fairly quiet and people respected others properties and tranquility. We Could trust our neighbors! Now, we never know who is going to be in the neighborhood. The PC sheriff has been called several times but cannot keep after these problems when they are handling other police business.

Owning a home in the USA is part of the American dream, it is where we build lives and communities. Allowing short term rentals in residential areas are shattering that dream by turning quiet neighborhoods into areas of transient residents. Recently, a good friend and long-time neighbor, was dying from cancer. There is an ABnB next door and behind his house. The rental house has an illegal pool (no setback) is only about 11’ from his bedroom window; even in his last months on earth he had no peace due to loud drunken parties.

These short-term rentals decrease the ability for affordable housing, increase the traffic load, impact the potable water supply and sewage treatment systems. Potential homeowners don’t want to buy or live in a disruptive environment with a steady stream of strangers, drunks and other questionable characters are coming and going. The ABnB businesses do not vet the renters and don’t care; we have tried to speak with the property owners to no avail. If you complain to ABnB, they want all of your information so there could be retaliation from the owners. We have retired, widowed and young folks here that need to stay safe.

In the Pinellas County Zoning ordinance, there are designations for what can be built and how the property can be used. Please read Sections 138.264 through 138.310 and the related table 138-355. This Pinellas County ordinance specifically does **NOT** allow businesses in a SF zones (our property use is 0110 SFH)! The State of Florida requires that a comprehensive zoning code be established.

Air BnB is most definitely a nationwide business who advertises on TV. Further, you can buy stock in the company. That is the classic definition of a business. Other short term rental companies are also businesses by definition.

Again, please note that the SF designation in Pinellas County ,and as a national standard, specifically excludes allowing businesses and table 138-355 clearly states what is, and is not, allowed. Further, Pinellas County requires that each short-term rental register with the county and they must abide by the regulations established by the County (quiet time after 10:00 PM etc.)

How will you and your friend like it when your neighborhoods are invaded by these short-term rental businesses in **your** single-family neighborhoods?

Now your agenda item # 35 (today's agenda) seeks to increase the density of these homes; shameful and illegal!

Short Term rentals should be banned to preserve the integrity of single-family neighborhoods and to allow working families housing availability.

Please, read your own zoning ordinance mandates and ban short term rentals in the single-family neighborhoods. You were elected to represent and protect the residents; please perform your duties.
