

SIXTH AMENDMENT

This Amendment is made and entered into on the date last executed below (“Effective Date”), by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as “County,” and ImageTrend, LLC, Eagan, MN hereinafter referred to as “Contractor,” (individually referred to as “Party”, collectively “Parties”).

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on November 15, 2022, referred to as Pinellas County Contract No. 22-0748-N (hereinafter “Agreement”), pursuant to which the Contractor agreed to provide Computer-Aided Dispatch (CD) Services for the County; and

WHEREAS, Section 25 (Amendment) of the Agreement permits modification by mutual written agreement of the Parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an increase to the contract value, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1 Section 6 (“Compensation and Method of Payment”), subsection B (“Spending Cap and Payment Structure”), is revised to reflect an increase to the total contract value in the amount of \$1,630,526.03 for a new total not-to-exceed sum of \$4,789,110.59.
2. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.

IN WITNESS WHEREOF the Parties herein have caused this Sixth Amendment to be executed by their undersigned officials, who are duly authorized to bind the Parties to the Agreement.
