Dear Ms. Farantos:

Oakbrook Plaza is located at 2475 McMullen Booth Road, within the City of Safety Harbor's jurisdiction. Mullet Creek runs through the center of the property in an east-west direction, with buildings located north and south of the creek. The creek discharges into Old Tampa Bay. The Environmental Protection Agency lists this water body as an impaired water body due to high levels of fecal coliform.

On April 20, 2023, the City of Safety Harbor received an e-mail from the Oakbrook Plaza property management company (phi-international), regarding a sewer odor that many tenants have been noticing at Oakbrook Plaza. The email is attached.

On February 21, 2018, the Safety Harbor Code Enforcement Board found Preedom Land Trust C/O KOS in violation of several Safety Harbor City Code sections regarding illicit discharge, spills and dumping, inspections and monitoring, plumbing systems and fixtures, and sanitary drainage system. During the board hearing, testimony was provided regarding laboratory results taken in 2017 and 2018 showing high counts of fecal coliform and e-coli at numerous locations in Mullet Creek that corresponded to stormwater vault outfalls at Oakbrook Plaza. Lab results are attached. It was also noted that Oakbrook Plaza's sanitary sewer connects to the City of Clearwater's sanitary sewer system. A lien was recorded on the property on August 16, 2018. A copy of the lien is attached. A fine of \$250/day is being assessed and the lien is currently in excess of \$450,000.

In 2019, a consultant contacted the City of Safety Harbor staff regarding a study they were conducting to address the illicit discharge. Since that time, the City of Safety Harbor has not received any information regarding the study, the case is still open, and the property is being fined daily.

Pinellas County's ambient water quality testing report card through 2021 is attached.

Please provide an update in writing regarding the status of this code enforcement case.

This Order shall be recorded and shall constitute a lien against any real or personal property owned

by the Respondent, and may be enforced in the same manner as a Court Judgment by the Sheriff of

this State, including levy against personal property, but shall not be deemed a Court Judgment except

for enforcement purposes as set forth in Florida Statutes Section 162.09. If the violation concerns

real property, the recording of a certified copy of this Order shall constitute notice to any subsequent

purchasers, successors in interest or assigns of the violation and the findings in this Order shall be

binding upon any subsequent purchasers, successors in interest or assigns of the real property where

the violation exists.


