Emergency Management  Development Discussion</p>	<p>Linda Fisher provided PAC members with information on a new version of the Sea, Lake and Overland Surges from Hurricanes (SLOSH). Since the Coastal High Hazard Area (CHHA) is determined by the SLOSH model, the CHHA has been updated as well. This new information took effect on August 4, 2021, but has not been pushed out to the community uniformly. Relative to the 2016 version, the 2021 CHHA acreage over land increased approximately 8,000 acres or 18%. The new data was emailed to PAC members on October 15, 2021 for local governmental use. Ms. Fisher also discussed Pinellas County Emergency Management is setting up a support team of key County and Forward Pinellas staff to develop clearer guidance to local governments for meeting state statutes pertaining to the CHHA, as well as update to the Countywide Rules CHHA balancing criteria, with the goal of establishing a more comprehensive set of strategies to address development in vulnerable areas.</p>
