**PETLAND WANTS TO TAKE AWAY YOUR RIGHT TO PROTECT PETS!** Dangerous legislation that is a betrayal of pets and the families who love them is headed to Governor DeSantis' desk. SB 620 would prevent cities and counties from regulating many businesses, including those that abuse dogs and cats. No additional localities would be able to stop the sale of puppy mill puppies in pet stores or crack down on local puppy mills.

This attack on animals, and home rule, comes after Petland spent heavily to ram this through the legislature. But, there is reason to believe Governor Ron DeSantis is hesitant to sign this into law as you can see [here](#).

Please politely urge Governor DeSantis to veto SB 620 to protect pets and consumers, not animal abusers! First, call **Governor DeSantis at 850-488-7146 ask him to veto SB 620.
