FIRST AMENDMENT

This Amendment is made and entered into this <u>23</u> day of <u>May</u>, 2025, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Brenntag Mid-South, Inc., Henderson, KY, hereinafter referred to as "Contractor," (individually referred to as "Party," collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on July 18th, 2023, referred to as Pinellas County Contract No. 23-0392-ITB (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide Sodium Hydroxide; and

WHEREAS, Section 36 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a term extension and an increase to the contract value at the same terms and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- In accordance with section 5 ("Term of Agreement"), subsection B ("Term Extension") of the Agreement, the Parties agree to extend the term of the Agreement an additional twenty-four (24) months from July 17, 2025, to July 17, 2027
- 2. Section 14 ("Compensation and Method of Payment"), subsection B ("Spending Cap and Payment Structure"), is revised to reflect an increase in the amount of Eight-Hundred Six Thousand, One-Hundred Twenty dollars and zero cents (\$806,120.00), for a new total not-to-exceed amount of One-Million, Six-Hundred Twelve Thousand, Two-Hundred Forty dollars and zero cents (\$1,612,240.00), and a new annual not-to-exceed expenditure of Four-Hundred Three Thousand, Sixty dollars and zero cents (\$403,060.00).
- Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
