**E.2.5.** For the measure in **E.1.5.**,

Total number of Program participants arrested or rearrested within 180 days following Program discharge.	≤	50%
Total number of Program participants who have been successfully discharged for 180 days		

**E.2.6.** For the measure in **E.1.6.**,

Total number of Program participants who report stable housing within 180 days following Program discharge	≥	75%
Total number of Program participants without stable housing at admission who have been discharged for 180 days
