### Description & Comments

(What is it, any issues found, is there a financial impact to current/next FY, does this contract vary from previous FY, etc.)

This item provides the Board with recommendations from the Pinellas Community Foundation and recommendations from staff to award \$10.5 million of the Round 1 of Large Capital Projects.

The PCF is recommending 12 applicants for funding totaling \$10.5 million. Staff is further recommending the following changes to the PCF's list:

- unassign the funding for the YMCA of Greater St. Petersburg, Inc. (because the applicant has substantial established resources and the demonstrated financial impact was not as great as others);
- unassign the funding for the Community Health Centers of Pinellas, Inc. DBA Evara Health (for the same reasons as the YMCA and the project will not directly counteract the effects of COVID-19); and
- unassign the funding for the African People's Education and Defense Fund, Inc. (because the project also will not directly counteract the effects of COVID-19).

Should these staff recommendations be accepted, the funds then available are recommended to be allocated to the next ranked partially-funded applicant - Gulf Coast Jewish Family and Community Services, Inc.

The total recommendation for funding remains at \$10.5 million.

Funding for this recommendation is budgeted in the ARPA Funds (Fund 1045) in FY23. It is within the \$10.5 million set aside for Round 1 of Large Capital Projects which is within the \$19 million that has been set aside for the Nonprofit Capital Program.
