The Pinellas County Board of County Commissioners will conduct a public hearing on proposed amendments to the FY2025 Budget as required by Section 129.06 (2), Florida Statutes, relating to the appropriation of unanticipated revenue as specified herein.

A public hearing on the Resolution with virtual public participation and an on-site participation option, to be held on Tuesday, October 29th at 6:00 p.m., or thereafter, in the Palm Room, 333 Chestnut Street, Clearwater, Florida 33756, with virtual participation utilizing Communications Media Technology (CMT) on the Zoom platform

Members of the public wishing to address the body may attend in person, attend virtually, or provide comments in advance.

To address the County Commission in person, members of the public are encouraged to preregister at Pinellas.gov/comment. Preregistration is encouraged but not required if individuals plan to attend the meeting at the Assembly Room. Those who have not preregistered may register when they arrive.

Members of the public wishing to address the body virtually via Zoom or by phone are required to preregister by 5:00 P.M. the day before the meeting by visiting Pinellas, gov/comment. The registration form requires full name, address, and telephone number if joining by phone, along with the topic or agenda item to be addressed. Written arguments, evidence, explanations, studies, reports, petitions, photos or other presentation materials and documentation that are to be presented or entered into the record for a public hearing item must be received not later than seven (7) calendar days prior to the public hearing.

Certain matters heard by the Board of County Commissioners are quasi-judicial in nature. Please note that only competent, substantial, fact-based testimony or evidence may be considered by the boards deciding the matters before them. Pure speculation or opinion, not based on competent facts, cannot be legally considered by the boards. Lay testimony with fact-based support (including but not limited to meeting minutes, surveys, engineering reports, etc.) may be considered competent and substantial evidence. Please note County Attorney's Office represents and advises the boards and county staff but cannot give legal advice to the applicant or other interested parties.

Appeals of any quasi-judicial final decision must be filed within 30 calendar days of the decision. Persons are advised that, if they decide to appeal any decision made at this meeting/hearing, they will need a record of the proceedings, and, for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony, and evidence upon which the appeal is to be hased.

Persons who are deaf or hard of hearing may provide public input on any agenda item through use of the State of Florida's relay service at 7-1-1.

The Resolution supplements the Fiscal Year 2025 (FY25) Adopted Budget for unanticipated revenue related to the issuance of debt for the Tampa Bay Rays Major League Baseball Stadium Project in St. Petersburg and realigns appropriations from Reserves in the Tourist Development Tax Fund for expenditure related to cost of issuance and debt service for the Tourist Development Tax Revenue Bonds, Series 2024.

The Resolution recognizes \$335,000,000 in unanticipated revenue in the Tourist Development Tax Fund from the issuance of Tourist Development Tax Revenue Bonds, Series 2024, and appropriates for payment of the County's commitment to the project. It also realigns \$35,000,000 from the Tourist Development Tax Fund Reserves to Transfer to TDT Debt Service Fund and recognizes \$35,000,000 in unanticipated revenue in the TDT Debt Service Fund from a Transfer from the Tourist Development Tax Fund for debt service expenditures and Debt Service Reserves. Additionally, it realigns \$4,700,000 from the Tourist Development Tax Fund Reserves to Debt Service Costs.

The total fiscal impact to the Tourist Development Tax Fund is a \$335,000,000 increase to revenue and expenditures. The total fiscal impact to the TDT Debt Service Fund is a \$35,000,000 increase to revenue and expenditures.

In review of the Resolution above, there may be modifications that arise at the public hearing and/or with other responsible parties.
