

## **AMENDMENT**

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc., a Delaware corporation ("Tyler"), and Pinellas County, a political subdivision of the State of Florida ("Client").

WHEREAS, Tyler and the Client are parties to an agreement dated December 14, 2010 ("Agreement");

WHEREAS, the Agreement was modified on March 22, 2021 to add Tyler's Enterprise Jury software, including Tyler Jury Capture-Lite ("Prior Amendment"); and

WHEREAS, Tyler and Client desire to further amend the terms of the Agreement as provided herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the Client agree as follows:

- 1. The Tyler Jury Capture-Lite software is hereby removed from the Agreement as of the Amendment Effective Date. Upon such date, Client's license for such software is terminated, as are Tyler's obligations to support, maintain, and update such software. Should Client wish to again license and/or use such software, Client shall first pay Tyler the then-current license fee(s) for the software, as well as fees for any required services, support or third party products.
- As of the Amendment Effective Date, the Enterprise Jury Voice software set forth in Exhibit 1 is
  hereby added to the Agreement. The license for the removed Tyler Jury Capture-Lite software
  shall transfer to the Enterprise Jury Voice software, and no additional license fees shall be due
  pursuant to this Amendment.
- 3. For the period October 1, 2023-September 30, 2024, there shall be no change in the total amount due under the Agreement for maintenance and support as a result of this Amendment. As of the annual maintenance term commencing October 1, 2024, the total maintenance and support fees due under the Agreement shall increase in the amount of \$4,189 for the addition of Enterprise Jury Voice (for an annual total of \$8,379 associated with maintenance and support for Enterprise Jury Voice). Subsequent annual maintenance and support fees shall be invoiced in accordance with the terms of the Agreement.
- 4. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement. Except as expressly indicated in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
