The OMB Grants Team has conducted a review of the **Human Services**' intent to apply for the **FFY24 Edward Byrne Memorial Justice Assistance Grant** funded by the **Bureau of Justice Assistance** passing through **Florida Department of Law Enforcement.**

Project Scope of Work

In general, JAGC funds may be used to implement programs in the following purpose areas: (1) Law enforcement programs; (2) Prosecution and court programs; (3) Prevention and education programs; (4) Corrections and community corrections programs; (5) Drug treatment and enforcement programs; (6) Planning, evaluation, and technology improvement programs; (7) Crime victim and witness programs (other than compensation); (8) Mental health programs and related law enforcement and corrections programs, including behavioral programs and crisis intervention teams; and (9) Implementation of state crisis intervention court proceedings and related programs or initiatives, including but not limited to: mental health courts; drug courts; veteran courts; and extreme risk protection order programs. Specific projects to be funded under JAGC will be selected by the Substance Abuse Advisory Board (SAAB) following a Countywide request for proposals. The SAAB is comprised of local community leaders in the justice system, law enforcement, and mental health programs.

Benefit Summary

The SAAB historically uses JAGC funds to support community projects that aim to promote public safety by improving the criminal justice system and reducing the recidivism. Projects selected by the SAAB must be approved by the Board of County Commissioners before applications are submitted to FDLE. Each Project funded under JAGC grant will be given a separate project number in OPUS.

Anticipated Impact to the County Budget

This is a **single-year** grant potentially affecting **FY25**. This application request is for \$232,520.00 with no cost share requirement.

Grant Review Comments

- If grant funding is awarded, the fiscal impact will be in later in FY25, and an analysis of the total project budget will be made at that time.
- The grant application will require Director approval for submission.
