The Environmental Management Division of Public Works is recommending the approval of the grant application to the United States Environmental Protection Agency. This grant application will provide additional funding to support the existing Air Pollution Control Program.

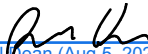
Public Works is seeking two project years of grant funding in the amount of \$663,092.00 (\$331,546.00 per project year). A match is required and estimated at \$1,547,212.00 over the two-year project period (\$773,606.00 for FY 2027 and \$773,606.00 for FY 2028). The grant is on a reimbursement basis. The source of the estimated total project costs of \$663,092.00 is the Environmental Management Division's Air Quality operating budgets for FY 2027 and FY 2028.

Authority for the Director of Public Works to sign this grant application is granted under the County Administrator's delegation of authority dated March 28, 2016.
