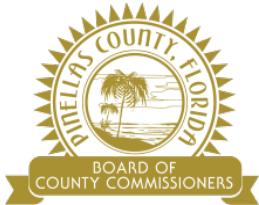

TLDR; Please appoint Gloria Lepik-Corrigan to your PSTA Board as Citizen Representative.

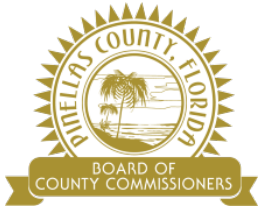
