Subject: 2015-16 Statewide Criminal Analysis Laboratory System Funding Agreement Closeout Process

Dear Commissioner Justice:

The Pinellas County Forensic Sciences Laboratory receives quarterly disbursements of collected controlled substance fines in accordance with Florida Statute 943.36, not to exceed 75 percent of the actual operating cost, to support crime laboratory operations.

In accordance with Florida Statute 943.36 and the terms of the agreement (CL004) each laboratory shall submit to the Florida Department of Law Enforcement (FDLE), on or before October 15, 2016 a written report containing the following:

- The operating budget approved by the county commission for the fiscal year in progress.
- The actual operating costs for the immediate prior fiscal year.
- Laboratory workload data, including, but not limited to, the volume of casework received and completed by type and sources of workload by law enforcement agency.

Additionally, FDLE is required to complete a financial reconciliation for this agreement that requires all agencies report expenditures funded by these quarterly disbursements. Prior year actual and current operating cost data must include an itemization of the actual expenditures paid from this agreement categorized by laboratory discipline. The report must indicate the portion of operating expenses funded by local or federal funds and specify the amount of the local appropriation to be used as the basis for computing the state's maximum 75 percent funding contribution.

Please complete and return the enclosed forms along with supporting expenditure documentation to the address below by October 15, 2016. If you are unable to submit reports by the deadline, please submit a written justification and request for extension.
