ORDINANCE NO. 2016-26

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, ANNEXING CERTAIN PROPERTY LOCATED AT 3250 ENTERPRISE ROAD EAST INTO THE CORPORATE LIMITS OF THE CITY OF SAFETY HARBOR; PROVIDING FOR PUBLICATION IN ACCORDANCE WITH THE REQUIREMENTS OF LAW; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Safety Harbor, Florida, has been petitioned by the owner of the property described herein to annex such property, which is reasonably compact, lying contiguous to the territorial limits of said City; and

WHEREAS, said petition was accompanied by all proper documentation certifying the titleholder to and ownership of said property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED that:

1. The City of Safety Harbor, Florida, hereby annexes into the corporate limits of the City of Safety Harbor, the following property legally described as:

LEGAL Being a Part of the East ½ of the West ½ of the SW ¼ of DESCRIPTION: the SE ¼ of Section 28, Township 28 S., Range 16 E., described as follows:

From the Southwest corner of the Southeast 1/4 of Section 28, Township 28 S., Range 16 E., run thence S 89°49'19" E., along the Section Line, 337.50 feet; thence run N 0°22'06" E., 30.0 feet for the POINT OF BEGINNING; thence run continue N 0°22'06" E., 478.55 feet, thence run S 89°49'19" E., 337.17 feet; thence S 0°20'22" W., 478.55 feet to the Northerly Right-of-Way of COUNTY ROAD NO. 102; thence run N 89°49'19" W., along said Northerly Right-of-Way Line, 337.48 feet to the POINT OF BEGINNING.


