I also understand the need to apply more stricter restrictions in certain aspects as "common sense is not that common" and some of the public may not realize what you are attempting to do. With that said i would like to weigh in on a few topics that you have discussed in detail but just some additional comments.

I do not need a reply to this email as these were just creative ideas that maybe you could mold into something useful. I do understand that people are starting to get a little "cabin fever" and are looking for some outlets and I do agree that if you do not apply certain restrictions people would probably not utilize self governance in the current situation. I am seeing a lot of essential business that have found creative ways to abide by the distancing rule, volume rule (no more than 10 people), etc. and it seems that there could be a balance between some of the current discussions.

1) Open beaches between 6 a.m. and 10 a.m. then again at 4 p.m.- (sunset)

2) Open beaches but no towels, lawn chairs, or coolers - this may stop groups/crowds

3) open beaches for walks/runs/bikes only no congregating in areas

4) maybe apply the same to parks - but make them free during this time

5) Pools for condos- no groups - maintain 6 feet apart - no parties (even families) - have the condo boards self regulate - maybe you restrict occupancy of people on a deck to be divided by 6' or something of the like with enforcement at the condo association level. No more than 10 people on a pool desk at a time and maybe no more than 5 in a pool- there is potential for a balance

6) Boating- seems like the boating community is heading advice, but if and only if you or the sheriff have any issues, maybe put a restriction on anchoring in the higher traffic areas if it becomes an issue

Dear Members of the Pinellas County Commission:

I saw a news item yesterday which indicated that you would be considering reopening the public beaches in Pinellas County. Obviously, the beach closures, as well as the closures of restaurants and other non-essential businesses, has had a devastating impact on the residents and business owners in Pinellas County, the effects of which will be felt for some time.

I know that you have many responsibilities, and each of you must weigh the interests of the public, the interests of the business owners in your districts, as well as evaluate the information provided to you by the experts with respect to the current crisis, in weighing the short term and long term impacts your decisions may have on the health, safety and welfare of the residents of Pinellas County.

In considering the reopening proposal, I know that you will be consulting with experts. In doing so, I wanted to suggest, if I may, the following areas of inquiry, so the decision you ultimately make, will be the best one, and in the best interests of all residents of our county:

- a. What is the current timeline of the Covid-19 virus, and the effect the reopening of the beaches could have on that timeline, including short term and long term Covid-19 containment and mitigation efforts in Pinellas County?
- b. What will be the direct and indirect impacts of a possible reopening , and the potential that any reopening, will act to draw additional travel to Pinellas County from both within and outside of Florida? What risks are posed by such travel to Pinellas County? What are the projections in terms of the increase in the number of people that may travel to Pinellas County in the event the beaches are reopened? What additional health risks will this pose to the residents of Pinellas County, both young and old, and those segments of our population most vulnerable to the Covid-19 virus in light of the current timeline?
- c. If a resolution is passed by the Commission to reopen the beaches, what is the best timeline for a reopening, and what will the be contingency plans in the resolution to address and mitigate the risks identified by your experts, that could or would potentially result from any reopening?
- d. In the event a resolution to reopen the beaches is passed by the Commission, what steps will be taken before it becomes effective, to educate the public as to reasoning for the reopening, and the rules that will be in effect upon reopening, to protect the residents of Pinellas County, (as well as those who may travel to Pinellas to visit our beaches?)

Whereas, the State of Florida does not currently have any order in place suggesting or requiring county governments to close access to beaches.

Whereas, beaches in the State of Georgia continue to remain open after the governor's executive order (<u>https://thehill.com/homenews/news/491157-georgia-beaches-reopen-after-governors-executive-order</u>).

Whereas, Volusia County (<u>https://www.news-journalonline.com/news/20200404/coronavirus-volusia-county-eases-restrictions-on-beach-closure</u>) and Brevard County (<u>https://www.clickorlando.com/news/local/2020/04/03/brevard-county-beaches-remain-open-with-heightened-restrictions-amid-covid-19-pandemic/</u>) are allowing limited activity on their beaches for essential exercise purposes in consideration of the Governor's State Order.

Whereas, the number of new cases daily within the State of Florida has flattened and begun to decline per public records (https://experience.arcgis.com/experience/96dd742462124fa0b38ddedb9b25e429).

Whereas, Pinellas County has a substantially lower than average positivity rate of 5.4% compared to the state average of 10.5% and compared to 17.5% in hotspots like Miami-Dade County (<u>https://experience.arcgis.com/experience/96dd742462124fa0b38ddedb9b25e429</u>).

Whereas, checkpoints put in place by the State of Florida at the state border and at airports will limit travel from high-risk areas of the country (<u>https://wsvn.com/news/local/florida/gov-desantis-orders-checkpoints-on-i-10-and-i-95-to-screen-travelers/</u>).

Whereas, enforcement of the beach closure is inconsistent across the county in various jurisdictions and within jurisdictions themselves (some areas have no barriers at beach access points, some have tape, and some have secured plywood barriers) causing dissent among citizens.

Whereas, the jurisdiction of Pinellas County over the beaches ends at the wet sand line (<u>https://go.activecalendar.com/pinellascounty/site/pressrelease/event/pinellas-county-beach-closures-faqs/</u>) leaving that area of the beach legally accessible if CDC guidelines are followed.

Whereas, limited access to the beaches for non-stationary activities such as jogging, walking, biking, and swimming can be performed in accordance with all CDC guidelines.

Now, therefore, I, as a resident of Pinellas County, respectfully request, for the reasons stated above, that the board of commissioners consider adopting a resolution that would (1) leave the beach closure resolution in place but (2) modify the requirements to permit non-stationary, essential exercise activities including walking, jogging, biking, and swimming in accordance with CDC guidelines in groups of no more than 10 and (3) request local jurisdictions to remove barriers barring beach access points to allow for this essential exercise.

I'm the parent of a 17-year-old swimmer for the Clearwater Aquatic Team (CAT), who like all Pinellas County swimmers has not been able to swim at The Long Center or anywhere else during this pandemic. Unlike other sports, swimmers train 52 weeks a year and can't replicate that training in the weight room, a typical backyard pool, or by shooting baskets in a driveway. Pinellas has a number of national-level high school and college swimmers and several Olympic hopefuls.

I urge you to reopen the beaches on a limited basis, perhaps from **sunrise to 9:30 AM.** This would enable serious swimmers- and others who wish to walk, swim or engage in paddle sports - to get in their much-needed workouts. From March 17-20, after the pools were closed but with the beaches still open, a number of elite youth swimmers gathered on area beaches in the early morning hours to train. They had the beaches virtually to themselves.

By limiting beach hours from sunrise to 9:30 a.m, you will avoid the masses that might gather to sunbathe and congregate in groups.

When government is using such extraordinary powers to curtail the freedoms of otherwise healthy citizens, it owes them an equally extraordinary level of accountability and transparency. BCC Agenda 4-16-2020 Date Your Stand on Oppose the Issue

Whereas, Agenda Item #1 of this Board of Commissioner meeting for Pinellas County is to consider a resolution to extend the local state of emergency without any modification. Whereas, the State of Florida does not currently have any order in place suggesting or requiring county governments to close access to beaches. Whereas, beaches in the State of Georgia continue to remain open after the governor's executive order (https://thehill.com/homenews/news/491157-georgiabeaches-reopen-after-governors-executive-order). Whereas, Volusia County (https://www.news-journalonline.com/news/20200404/coronavirus-volusiacounty-eases-restrictions-on-beach-closure) and Brevard County (https://www.clickorlando.com/news/local/2020/04/03/brevard-county-beachesremain-open-with-heightened-restrictions-amid-covid-19-pandemic/) have beach closures that now permit non-stationary activity on their beaches for essential exercise purposes (including walking, jogging, biking, and swimming) in consideration of the Governor's State Order. Whereas, no comment from the State Governor, CDC, or Florida Department of Health has condemned the actions of Volusia County or Brevard County for loosening their beach closure policies. Whereas, the number of new cases daily within the State of Florida has flattened and begun to decline per public records (https://experience.arcgis.com/experience/96dd742462124fa0b38ddedb9b25e429). Whereas, Pinellas County has a substantially lower than average COVID-19 positivity rate of 5.4% compared to the state average of 10.5% and compared to 17.5% in hotspots like Miami-Dade County Comments (https://experience.arcgis.com/experience/96dd742462124fa0b38ddedb9b25e429). Whereas, checkpoints put in place by the State of Florida at the state border and at airports will limit travel from high-risk areas of the country (https://wsvn.com/news/local/florida/gov-desantis-orders-checkpoints-on-i-10-andi-95-to-screen-travelers/). Whereas, enforcement of the beach closure is inconsistent across the county in various jurisdictions and within jurisdictions themselves (some areas have no barriers at beach access points, some have tape, and some have secured plywood barriers) causing dissent among citizens. Whereas, the jurisdiction of Pinellas County over the beaches ends at the wet sand line (https://go.activecalendar.com/pinellascounty/site/pressrelease/event/pinellascounty-beach-closures-faqs/) leaving that area of the beach legally accessible if CDC guidelines are followed. Whereas, limited access to the beaches for nonstationary activities such as jogging, walking, biking, and swimming can be performed in accordance with all CDC guidelines. Now, therefore, I, as a resident of Pinellas County, oppose simply extending the state of emergency order without modification and instead respectfully request, for the reasons stated above, that the board of commissioners consider adopting a modified resolution that would (1) continue the state of emergency, (2) leave the beach closure resolution in place, but (3) modify the beach closure resolution to permit non-stationary, essential exercise activities including walking, jogging, biking, and swimming in accordance with CDC guidelines in groups of no more than 10 and (4) request local jurisdictions to remove barriers barring beach access points to allow for this essential exercise.

Wishing health to you and your families. The Commission has done well under novel and difficult circumstances.

Following is an email to Commissioner Long about an issue I think deserves consideration. I've tried to briefly sketch what seems an unconsidered outcome of the Commission's order to close public gathering spots. In short, while it seems within the powers of government to issue shut down orders affecting commerce and corporately (still a non-person/individual under most legal interpretations) owned assets on various legal theories, it seems governmental overreach abrogating at least U.S. and State of Florida Constitutional holdings on private property to shut down, "take" or diminish owner's rights in private property. Note that Business has been suspended and COUNTY owned property regulated by properly elected officials has been closed BUT a property owner's right to visit, work in, use, or to reside in privately owned property has not been abridged at any governmental level so far - (except in the instance of private fractionally owned pools). That is the essence of the Commission's order as I read it.

Please read my note to Commissioner Long. My request is that the Sheriff be ordered to reopen privately held well regulated non-public pools.

Commissioner Long,

The positions and actions taken by the Commission are necessary however please study the legality of closing privately owned pools. Three weeks ago a Deputy stopped by our private pool with an order to the HOA to

close and lock. The HOA had for almost a week and a half prior posted a "No more than 10 and maintain 6 feet separation" within our pool area. Residents were complying without exception.

I am under the inclination to believe this closure was/is based on the county's/city's/state's ability to control commerce - business. It was and is right to close businesses and within the legal power of government so to do. However when government extends its power to "take" PRIVATE property by issuing close orders to privately owned and non-business pools (and ones already well regulated to avoid spread of coronavirus), government has overstepped its authority.

A Marriott Hotel guest does not have an incidence of ownership in the pool on hotel property, a pool that is present for the business revenue enhancement of the hotel corporation. It is quite a different legal situation when I, as a unit owner in a townhouse PUD (own the land and mineral rights beneath the townhome foundation and outward as displayed on county plat maps in the County Clerk's office and fractional ownership of the "commons" administered by the townhome PUD HOA) and payer of monthly fees to cover maintenance of my fractional ownership interest in commons - such as the pool - am diminished in my ownership by being locked out of my property - the pool) by sheriff's order.

I would greatly appreciate the Commission putting the issue before the county attorney for review, that is, does the county have legal right to close down well regulated privately owned pools resting on private property there for the benefit of only their owners.

I maintain the county does not have the legal power as presently invoked to diminish the owners' right to "enjoy and quietly keep" their pool ownership interest.
