The Department of Administrative Services (DAS) is seeking the approval of Second Amendment to the Agreement with Johns Eastern Company, Inc. (Johns Eastern) for workers compensation third party administration services. This contract (21-0239-P) was originally approved by the Board of County Commissioners (BCC) on September 9, 2021, with a not-to-exceed threshold of \$1,236,600.00 for a sixty-month term. First Amendment was approved in June 2024; however, it had no fiscal impact and only recognized a corporate name change.

The proposed Second Amendment to the agreement will increase the not-to-exceed threshold from \$1,236,600.00 to \$1,286,600.00, for a difference of \$50,000.00, or 4.0%, and adds a part-time injury counselor. This request is sufficiently budgeted for in the FY24 Adopted Budget of the Department of Administrative Services in the Risk Financing Fund and is included in the FY25 Budget.
