	sense that their lives are back to normal. For some, the damage is permanent. Their organs will never fully heal. "When they say							
	'recovered,' they don't tell you that that means you may need a lung transplant," Antoinette wrote in a Twitter post. "Or that you

	1) Everybody is so swollen their skin has blisters and is so tight it looks like it's about to burst, from head to heel. And skin so dry

	2) Everybody's skin is weeping clear fluid and has sores and the skin just slides off with slightest turn or rub, all over the body.							
	3) Everybody's blood is thick as slush. Can't figure out what's making it clot like that, but it's dark and thick.							
	4) Everybody's kidneys are failing. Urine dark or red, which could contribute to the swelling, but we don't know yet.							
	5) Everybody has an abnormal heart rhythm. Not sure of the cause. But even without underlying heart problems, it's not beating normally.							
	6) Seems counterproductive, but the ones that are not breathing on the ventilator have to lay flat on their stomachs to breathe
