Summary:

On December 2, 2019, a now former Pinellas County employee was operating a County-owned vehicle while acting in the scope of his employment near Gulf-to-Bay and Comet Avenue in Clearwater. The County employee struck a vehicle in which a husband, wife, and minor child were riding. As a result of the accident, all three Plaintiffs were injured. The County driver was cited by law enforcement in the accident and disciplined by the County for negligence. This settlement will resolve all Plaintiffs' claims, including a \$5,000.00 settlement to be apportioned to pay for legal fees associated with the necessary court approval of the settlement on behalf of the minor Plaintiff.
