The Forward Pinellas public hearing will be held on Wednesday, June 9, 2021, at 1:00 P.M. or as soon thereafter as the agenda permits, in the Magnolia Room at the Pinellas County Cooperative Extension, 12520 UI: merton Road, Largo, Florida,

Forward Pinellas will make an advisory recommendation to the Pinellas County Board of County Commissioners, acting in its capacity as the Countywide Planning Authority (CPA), on the proposed amendment.
