

RESOLUTION NO. 18-41

A RESOLUTION APPROVING THE ISSUANCE BY THE HOUSING FINANCE AUTHORITY OF PINELLAS COUNTY OF ITS MULTIFAMILY HOUSING REVENUE BONDS (PALMETTO POINTE APARTMENTS), SERIES 2018 IN THE AGGREGATE AMOUNT NOT TO EXCEED \$9,500,000 TO PROVIDE FUNDS TO FINANCE THE MULTIFAMILY RESIDENTIAL RENTAL HOUSING PROJECT FOR THE BENEFIT OF SP PINELLAS I LLC, A FLORIDA LIMITED LIABILITY COMPANY, OR ITS AFFILIATE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Housing Finance Authority of Pinellas County, Florida (the "Authority") has authorized the initiation of official action to issue its Multifamily Housing Revenue Bonds (Palmetto Pointe Apartments), Series 2018 (the "Bonds") on behalf of SP Pinellas I LLC, a Florida limited liability company, to provide financing for the acquisition, construction, and equipping of a residential rental facility to be known as Palmetto Pointe Apartments, to consist of approximately 82 units located on approximately 3.4 acres of land located on the East side of 49<sup>th</sup> Street, North, approximately 480 feet North of the intersection of 78<sup>th</sup> Avenue N and 49<sup>th</sup> Street, North, Pinellas Park, Florida; and

WHEREAS, the Authority conducted a public hearing on June 22, 2018, notice of which hearing was published on June 6, 2018, in the *Tampa Bay Times* (a copy of which notice is attached hereto as Exhibit "A" and incorporated herein), for the purpose of considering the issuance of the Bonds by the Authority in the aggregate principal amount not to exceed \$9,500,000, in conformance with the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended. Said public hearing disclosed no reason why the Bonds should not be issued.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA (THE "BOARD"):

Section 1. The Board, pursuant to and in accordance with the requirements set forth in Section 147(f) of the Internal Revenue Code of 1986, as amended, hereby approves the issuance by the Authority of its not to exceed \$9,500,000 Multifamily Housing Revenue Bonds (Palmetto Pointe Apartments), Series 2018.

Section 2. Nothing contained in this consent and approval shall be deemed to create any obligation or obligations of Pinellas County or the Board of County Commissioners.

Section 3. This resolution shall take effect immediately upon its adoption.



Notice is hereby given that the Housing Finance Authority of Pinellas County, Florida (the "Authority") will hold and conduct a public hearing to be held on June 22, 2018 beginning at 8:30 a.m. or as soon thereafter as such matters may be heard, at the Pinellas County Board Records Conference Room, Fifth Floor, Pinellas County Courthouse, 315 Court Street, Clearwater, Florida, for the purpose of receiving comments and hearing discussion concerning a plan of financing (within the meaning of Section 147(f) of the Internal Revenue Code of 1986, as amended), on the following:

The proposed issuance by the Authority of its Multifamily Housing Revenue Bonds (Palmetto Pointe Apartments), Series 2018, in an aggregate principal amount of not to exceed \$9,500,000 in one or more installments or series, the proceeds of which will be used to finance the acquisition, construction and equipping of an 82 unit multifamily rental housing facility consisting of four buildings containing 1, 2 and 3 bedroom units for persons or families of moderate, middle or lesser income within the City of Pinellas Park, Pinellas County, to be located on approximately 3.4 acres of land located on the East side of 49th Street, North, approximately 480 feet North of the intersection of 78th Avenue N and 49th Street, North, Pinellas Park, Florida. Palmetto Pointe Apartments will initially be owned and operated by SP Pinellas I LLC, a Florida limited liability company, or one of its affiliates.

All interested parties are invited to present their comments at the time and place set forth above.

Persons are advised that, if they decide to appeal any decision made at this hearing, they will need a record of the proceedings, and, for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
