## SECOND AMENDMENT

This Amendment is made and entered into this 10 day of March, 2025, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and NDL, LLC dba Natural Designs Landscaping, Lutz, FL, hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

## WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on April 11, 2023, pursuant to Pinellas County Contract No. 23-0208-ITB (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide Grounds Maintenance, Public Works Medians, Right of Way and Pond Outparcels services for the County; and

WHEREAS, Section 25 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to renew the contracted services, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- In accordance with Section 5 ("Term of Agreement"), subsection B ("Term Extension"), the
  parties agree to exercise the first twenty-four (24) month extension period, resulting in a
  new contract end date of April 10, 2027.
- 2. Section 6 ("Compensation and Method of Payment"), subsection B ("Spending Cap and Payment Structure"), is revised to reflect an increase in the amount of One Million, Five Hundred Forty Thousand, Five Hundred Sixty-One Dollars and Twelve Cents (\$1,540,561.12), for a new total not-to-exceed sum of Three Million, Four Hundred Forty-Eight Thousand, One Hundred Twenty-Two Dollars and Eighty-Two Cents (\$3,448,122.82), and a new annual not-to exceed expenditure of Eight Hundred Sixty-Two Thousand, Thirty Dollars and Seventy-One Cents (\$862,030.71).
- Except as changed or modified herein, all provisions and conditions of the original
   Agreement and any amendments thereto shall remain in full force and effect.
