Case No. CW 20-05 - City of Tarpon Springs Countywide Plan Map amendment from Activity Center to Activity Center, regarding 1.46 acres more or less, located at the northeast corner of East Live Oak Street and North Hibiscus Street, south of Athenian Way.

Recommendation:

- * The proposed amendment would amend the local zoning designation from T5d (North Pinellas Avenue Character District) to T4c (Residential High Character District) within their Activity Center.
- * The proposed amendment would allow for the subject property to be redeveloped into townhomes.
- * Due to a restrictive covenant placed on the property, there will be no increase in the allowable density standard of 15 units per acre.
- * The parcel is currently vacant.
- * The Activity Center category is appropriate for the proposed use of the property and is consistent with the criteria for utilization of this category.
- * The proposed amendment either does not involve, or will not significantly impact, the remaining relevant countywide considerations.
- * Forward Pinellas, in its role as the Pinellas Planning Council, voted 12-0 to recommend approval of the proposal.
- * The Planners Advisory Committee recommended approval of the case by a vote of 14-0.

- * This site is being subdivided into eleven single family lots and one tract.
- * The site is designed to be a public subdivision and the one tract will be dedicated to the Home Owners Association.

- * Three Small Business Enterprise (SBE) firms are included with Ardurra's submittal for structural engineer, electrical engineering, and instrumentation and controls services for combined SBE fees of \$221,572.11, or approximately 29% of the total award.

Contract No. 190-0031-NC (SS); in the amount of \$752,557.11. The design, permitting, bidding and construction administration process are expected to be completed within nine hundred and ninety consecutive calendar days. Authorize the Chairman to sign and the Clerk of the Circuit Court to attest.

Declare escheated property surplus and authorize transfer of the property by donation to Habitat for Humanity of Pinellas County, Inc.

Recommendation:

Adoption of a Resolution to declare an escheated property surplus and authorize the transfer of the parcel by donation to Habitat for Humanity of Pinellas County.

- * The property is a vacant parcel 0.13 acres in size (50' x 110') located at 1304 Pennsylvania Ave in the North Greenwood community of Clearwater.
- * This property was not transferred to the City of Clearwater and is identified as needed for infill housing.
- * Appropriate County Departments have reviewed the property and determined that the County has no use for it and the best use would be for infill housing.

Authorize the Chairman to sign the County Deed and the Clerk of the Circuit Court to attest the Resolution and County Deed and record in the Public Records of Pinellas County.

13. 20-448A

Purchase Agreement with the Florida Department of Transportation for a portion of a County-owned parcel in support of the U.S. 19 road improvement project from Northside Drive to north of CR 95.

Recommendation:

Approval of the resolution declaring a portion of a County-owned parcel (Property) surplus, execution of a purchase agreement, and grant authorization to sell to the Florida Department of Transportation (FDOT) in support of the U.S. 19 road improvement project from Northside Drive to north of CR 95 (Project).

- * The Project will rebuild U.S. 19 between Northside Drive and CR 95 creating a six-lane controlled access road with one-way frontage roads in the north and south bound directions.
- * The Property is necessary for the roadway improvement project for access for construction and maintenance activities related to a retaining wall along U.S. 19 and an access corridor to an outdoor advertising sign site.
- * The purchase price is \$121,711.00 based on an appraisal submitted by FDOT.

Authorize the Chairman to sign and the Clerk of the Circuit Court to attest the County deed. It is further recommended that the Board of County Commissioners sign and approve the addendum to the contract and authorize the Clerk of the Circuit Court to record the resolution in the public records of Pinellas County.

14. 20-469A

Seventh Amendment to the purchase authorization with Genuine Parts Company d/b/a NAPA Auto Parts for the supply of vehicle and equipment parts.

Recommendation:

Approval of the Seventh Amendment to the purchase authorization with Genuine Parts Company d/b/a NAPA Auto Parts (NAPA) for a vehicle and equipment parts management system.

- * This purchase authorization provides the Fleet Management Division of Administrative Services with all the parts required to support the maintenance and repair of vehicles in the County Fleet.
- * The Seventh Amendment extends the purchase authorization through July 21, 2025 to co-terminate with the Sourcewell contract extension with NAPA.
- * The Seventh Amendment also revises pricing to include more favorable parts pricing to the County.
- * Sourcewell is a public agency serving as a national municipal contracting organization established under the State of Minnesota.
- * Locally, Hillsborough and Polk counties and the cities of St. Petersburg and Pinellas Park utilize this Sourcewell NAPA contract to provide parts for their respective fleet operations.
- * The outsourcing of Fleet Management's parts supply and parts inventory eliminates inventory shrinkage and obsolescence as NAPA operates a parts warehouse on Fleet Management property and is responsible for manning the warehouse, and the disbursement and inventory of all parts.
- * Before the NAPA contract was utilized, over thirty County contracts were required to provide Fleet Management with parts requirements requiring inventory management and control by Fleet Management personnel.
- * The Board of County Commissioners approved the use of this contract on November 18, 2014.

Contract No. 134-0296-PB(AM) increase in the amount of \$11,603,826.00 for a revised contract value of \$20,283,826.00; with an annual amount of \$1,901,608.69; effective through July 21, 2025. Authorize the Chairman to sign and the Clerk of the Circuit Court to attest.

Recommendation:

Due to exigent circumstances, the County Administrator executed the grant application to expedite processing by the FAA.

- * Title XII of the CARES Act provides approximately \$10 billion to support U. S. airports experiencing severe economic disruption.
- * The funds are being given to prevent, prepare for, and respond to the impacts of the coronavirus (COVID-19) pandemic.
- * PIE's grant amount is \$8,737,268.00. No local match is required.
- * The grant must be expended within four years.

16. 20-839A

Coronavirus Aid, Relief, and Economic Security Act funding grant agreement designated for the St. Pete-Clearwater International Airport.

Recommendation:

Approval of the grant agreement that the St. Pete-Clearwater International Airport (PIE) received from the Federal Aviation Administration (FAA) as a result of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act).

- * Title XII of the CARES Act provides approximately \$10 billion to support U.S. airports experiencing severe economic disruption.
- * The funds are being given to prevent, prepare for, and respond to the impacts of the coronavirus (COVID-19) pandemic.
- * PIE's grant amount is \$8,737,268.00. No local match is required.
- * Funding can be used to restore lost revenue as a result of the COVID-19 pandemic. PIE estimates to have lost approximately \$4.7M due to COVID-19, to date.
- * The grant must be expended within four years.
- * Until December 31, 2020, PIE must continue to employ 90% of the personnel that were employed on March 27, 2020.

Authorize the Clerk of the Court to attest the CARES Act grant agreement document.

- * Each Agreement has been negotiated by staff to include tourism promotion benefits, which are detailed in Exhibit B.
- * Payments through the Capital Project Funding Program are made on a reimbursement basis at project completion.

Authorize the Chairman to sign and the Clerk of the Circuit Court to attest.

- * The Board of County Commissioners (Board) approved this contract on June 19, 2018 in the amount of \$156,000.00. The Division Director of Purchasing and Risk Management acknowledged a name change on January 31, 2020.

Contract No. 178-0174-P(LN), increase in the amount of \$156,000.00 for a revised total contract value of \$312,000.00 with an annual amount of \$78,000.00; effective through June 30, 2022. Authorize Chairman to sign and Clerk of Circuit Court to attest.

- * The JAG-C is a U.S. Department of Justice pass-through grant administered by the Florida Department of Law Enforcement. It supports projects that help reduce crime and improve the criminal justice system.
- * The JAG-C will provide \$268,112.00 in funding to support seven projects in Pinellas County.

- * The current plan is set to expire on June 20th, 2020.
- * The BHTP Three Year Renewal renews the existing plan through 2023. It was reviewed and authored by the Pinellas County Acute Care Committee led by Central Florida Behavioral Health, and provided for Board of County Commission approval prior to submission to Florida Department of Children and Families.
- * The BHTP remains fluid at this time as key stakeholders continue to meet, and projects are underway that may necessitate an update to this plan prior to the new expiration of 2023.
- * In accordance with Florida Statute 394.462, a transportation plan shall be developed by each county in collaboration with the managing entity.
- * The BHTP provides guidance on how the community shall support and facilitate access to the Designated Receiving System.
- * There is no direct fiscal impact as a result of this plan renewal and is consistent with the development of the FY20 budget.

Public Participation Procedures

Persons wishing to comment regarding a specific agenda item should do so in advance in accordance with the instructions in the notice of this meeting, or on the virtual platform or phone will be instructed before each vote during the virtual meeting how to do so. At the scheduled section of the meeting when the item is before the Board of County Commissioners (Board), the Chairman will call on each individual, one by one to be heard. Each individual may speak for up to three minutes as may be modified by the Chairman. Comments or behavior that violate Pinellas County Commission Public Participation and Decorum Rules will be disconnected.

Public Hearing Procedures

The procedure used by the Board in conducting Public Hearings is to have a staff presentation followed by the applicant presenting the specific proposal. The Board will then hear comments from the proponents, the opponents and a staff summary. The applicant will then be given an opportunity to close and the Board will decide on the matter.

Public Hearings before the Board are governed by the provisions of Section 134-14 of the Pinellas County Land Development Code as may be modified by Pinellas County Emergency Order. That code provides that at the conclusion of each person's presentation, any speaker may seek the Chairman's permission to ask questions of staff. Specifically:

- At the conclusion of the presentations by the applicant and any proponents, all affected parties may seek the Chairman's permission to ask questions of or seek clarification from the applicant and/or the proponents.
- 2. At the conclusion of the presentation by the opponents, all affected parties may seek the Chairman's permission to ask questions of or seek clarification from any opponent.

The applicant's closing comments will address testimony subsequent to his or her presentation. Continuing rebuttal of other than directly preceding testimony will not be allowed. Because much testimony has already been submitted in writing, the following guidelines accommodate efficient presentations:

- 1. The applicant should present his or her entire case, including rebuttal, in no more than 20 minutes.
- 2. Persons wishing to speak regarding a Public Hearing item may speak for up to three minutes each after virtually raising their hand as directed during the meeting.

Appeals

Persons are advised that, if they decide to appeal any decision made at this meeting/hearing, they will need a record of the proceeding, and, for such purposes, they may need to ensure that a verbatim record of the proceeding is made, which includes the testimony and evidence upon which the appeal is to be based.

If a Board meeting beginning at 9:30 A.M. has not concluded by noon, a recess will be taken from noon to 12:30 P.M., and the remainder of the meeting will continue at 12:30 P.M.

If a Board meeting beginning at 2:00 P.M. has not concluded by 5:30 P.M., a recess will be taken from 5:30 to 6:00 P.M. The remainder of the afternoon agenda will resume at 6:00 P.M., followed by Public Hearings.
