#### **Summary:**

Change Order No. 5 will allow additional cleaning of all walls and machine scrubbing the floors on a monthly basis of rooms 139, 141, 200, 300, 400, 403, and 600 at Animal Services.

## **Background/Explanation:**

On March 20, 2018, the Board of County Commissioners approved the award of bid to American Facility Services, Inc. for requirements of janitorial services.

On September 14, 2018 the Board approved Change Order No. 1 adding four (4) new locations.

On February 11, 2019 the County Administrator approved Change Order No. 2 updating service levels cleaning.

On May 31, 2019 and the County Administrator approved Change Order No. 3 changes to locations and increase in service levels cleaning.

On July 18, 2019 the Purchasing Director approved Change Order No. 4 changes to locations and increase in service levels cleaning.
