Palm Harbor Library is funded by a separate property tax levy apart from the General Fund and does not receive any General Fund tax support. It operates as a division of the Palm Harbor Community Services Agency.

FY22 ACCOMPLISHMENTS

Facility Enhancements:

- -Installation of an upgraded phone system
- -Installation of protective aluminum canopies on the west and east sides of the building
- -Installation of a new digital road sign
- -Installation of an upgraded book/DVD lending machine
- -Replacement of carpeting in the Adult Services area

Outreach:

- -Re-established the Meals-on-Wheels partnership
- -Celebrated one year anniversary of the Palm Harbor non-profit group, PHIN (Palm Harbor Institutes of Non-Profit)

Projected FY23 Revenue Sources

Operational Expenses from Ad Valorem Taxes- \$1,323,120 @0.5000 millage

Pinellas Public Library Cooperative- \$287,700 @ 0.5000 (projected)

Palm Harbor Friends of the Library-\$30,000

Facility Rentals- \$2,000

Miscellaneous- \$20,000

(These monies consist of such areas as donations, faxing, interest income, notary, printing income, etc.)

Total estimated revenue is \$1,662,820

All projected funding sources will be enough to maintain and expand current operational services, provide minor building enhancements and upgrade personnel positions.
