Please ban the existing retail pet stores from selling dogs and cats. There is little consumer protection for buyers and solid proof these pups come from puppy mills. The Pinellas county presentation on this topic states:

## Research supports:

:- USDA is not adequately regulating the dog breeding industry

- The USDA is failing to safeguard the health and welfare of the dogs being produced by the industry.


## Consumer Protection:

Florida Department of Agriculture

- Doesn't provide any additional protections for the dogs transported into the state for sale.
- Requires the Official Certificates of Veterinary Inspection on each dog to be submitted for record-keeping.
- Provides little protection for consumers with the Pet Lemon Law, FS828.29

The county's ordinance allows the stores to sell to other buyers, so they will never phase-out.
Every other surrounding county has banned retail pet stores, as have 75 Florida jurisdictions and 5 states. Jennifer Hobgood, the Senior Director of State Legislation with the ASPCA, spoke at the Manatee County Commission Meeting for the ban of retail pet sales. She stated public information in Florida clearly shows that puppies sold at retail stores come from puppy mills. Their staff analyzed over 5,000 input reports from the Florida Department of Agriculture over a 6-month period and found puppy
importers and breeders brought 12,000 puppies into Florida to sell at pet stores with more than $80 \%$ of those originating in only five Midwestern states that have the highest concentration of puppy mills; Missouri, Indiana, lowa, Ohio, and Kansas. One in four of the puppies shipped to Florida stores came from breeding and brokerage facilities in Missouri alone. This leads to contagious and hereditary illnesses in puppies and of course the suffering of the breeder dogs. In June 2021, the ASPCA filed a lawsuit against the USDA for failure to enforce the Animal welfare act because even if a puppy mill passes inspection, the USDA standards are so low, they are considered inhumane by animal organizations, and most people.

I am for a full retail pet store ban in Pinellas County, and not grandfathering in the 6 stores already in business. Thank you for your consideration on this urgent matter!

Dear Commissioners,
Please ban the existing retail pet stores from selling dogs and cats. There is little consumer protection for buyers and solid proof these pups come from puppy mills. The Pinellas county presentation on this topic states:
Research supports:
:- USDA is not adequately regulating the dog breeding industry

- The USDA is failing to safeguard the health and welfare of the dogs being produced by the industry.

Consumer Protection:
Florida Department of Agriculture

- Doesn't provide any additional protections for the dogs transported into the state for sale.
- Requires the Official Certificates of Veterinary Inspection on each dog to be submitted for record-keeping.
- Provides little protection for consumers with the Pet Lemon Law, FS828.29

The county's ordinance allows the stores to sell to other buyers, so they will never phase-out.
Every other surrounding county has banned retail pet stores, as have 75 Florida jurisdictions and 5 states. Jennifer Hobgood, the Senior Director of State Legislation with the ASPCA, spoke at the Manatee County Commission Meeting for the ban of retail pet sales. She stated public information in Florida clearly shows that puppies sold at retail stores come from puppy mills. Their staff analyzed over 5,000 input reports from the Florida Department of Agriculture over a 6 -month period and found puppy importers and breeders brought 12,000 puppies into Florida to sell at pet stores with more than $80 \%$ of those originating in only five Midwestern states that have the highest concentration of puppy mills; Missouri, Indiana, Iowa, Ohio, and Kansas. One in four of the puppies shipped to Florida stores came from breeding and brokerage facilities in Missouri alone. This leads to contagious and hereditary illnesses in puppies and of course the suffering of the breeder dogs. In June 2021, the ASPCA filed a lawsuit against the USDA for failure to enforce the Animal welfare act because even if a puppy mill passes inspection, the USDA standards are so low, they are considered inhumane by animal organizations, and most people.
I am for a full retail pet store ban in Pinellas County, and not grandfathering in the 6 stores already in business. Thank you for your time.

Hello Commissioners and Mr. Chairman, Thank you for your time and attention on the puppy mill and pet retail sales issue! It's an important animal welfare and consumer protection issue.
It sounds like the final decision at tomorrow's meeting may be to grandfather in the existing stores and prevent any future puppy selling pet stores from opening in your county although I hope you are still open to a phase out of the sale of dogs, cats and rabbits with a requirement for the stores to transition to a more humane pet store model selling goods/ services and not selling pets.
I cannot attend your meeting (although several volunteers plan to attend) because I will be attending a county commission meeting on the east coast of FL supporting a proposed ordinance that will phase out the retail sale of dogs, cats \& rabbits in 1 years' time. The proposed ordinance stipulates the stores must adhere to a humane pet store model (which is more profitable anyway) and phase out the retail sale of dogs, cats and rabbits.

High volume retail sales require high volume breeders. And responsible breeders are just thatresponsible. A responsible breeder would never sell their puppies to a pet store- don't take my word for it, ask a responsible breeder in your community. It's actually in their code of ethics.
Everyone knows puppy selling pet stores source their puppies from puppy mills, a dirty, cruel and inhumane business. And the consumer protection issue is equally problematic. AG Ashley Moody's office has an ongoing investigation into a Petland store in Orange County due to the high volume of complaints. Clearly there is reason for concern if her office is investigating.
There is endless research on the cruelty of puppy mills and in fact the Humane Society of the United States has an entire department working on puppy mills nationwide. The animal welfare community often has varied opinions on issues, but there is strong agreement community wide on the opposition of puppy mills and pet retail sales. The HSUS worked closely with Orange and Manatee Counties on their ordinances that passed in 2021.
I do understand the pushback from the other side and have some understanding of the difficult decisions in your duties as a county commissioner. (thank you)
I trust you all will do as you think is best for your community but just a few quick points:

- 84 municipalities in Florida have enacted similar ordinances phasing out the retail sale of pets
- This is about right versus wrong and the humane treatment of animals- don't be fooled. Puppy selling pet stores do source from puppy mills.
- The consumer protection and predatory lending concerns are very real.
- There are 12 Petland stores nationwide that do not sell puppies. And countless independently owned stores that do not sell puppies.
- Yes, we are working on this at the state level but it will take some time...

We would very much support a decision to phase out and ultimately prohibit the retail sale of dogs, cats and rabbits and require pet stores to adopt to a humane pet store model and truly appreciate your time and efforts on this important issue.

## Pet Store Industry Trends \& Leader Quotes

When faced with legislation that would prohibit pet stores from selling commercially raised puppies and kittens, puppy-selling pet store owners and lobbyists argue the policy would put them out of business. Yet, they also admit only $4 \%$ of Americans obtain pets from pet stores and their own industry repeatedly points to the fact that a products and services model is the key to pet retail success.

According to the American Pet Products Association:

- Americans spent $\$ 103$ billion on their pets in 2020 with pet food, products, and services dominating.
- Dog and cat sales were excluded for the second year because they are a "relatively small contributor to overall sales" and are "typically obtained outside of the retail pet channel."
- Despite the challenges of the pandemic, "pet specialty and independent retailers experienced solid growth in 2020."
- Stores added services like boarding, grooming, insurance, training, pet sitting and walking services to have an edge over online retailers.

According to Pet Business Magazine, of the top 25 pet retailers in North America only one sells puppies, and that chain (Petland) has moved down the list. Despite the challenges of the COVID-19 pandemic, "the pet industry's biggest retail chains continued to thrive by leveraging their unique strengths while developing new channels to reach consumers." In fact, more than half of the top retailers expanded in 2020.

According to Ex-Parthenon, one of the largest consulting organizations in the world, the pet store industry has become "a potentially explosive market" as Americans are increasingly spending more on fancy food, treats, clothing, and premium services, and $78 \%$ of people prefer to shop for their pets in brick-and-mortar stores.

According to the World Pet Association, in 2019 pet stores that only sold dry goods reported more total revenue per square foot (\$403) than those that sold animals (\$246).

Woof Gang Bakery \& Grooming, the $8^{\text {th }}$ largest pet store chain, added 15 new locations in 2020 and reported the average per-store revenue was up by more than $23 \%$. The key factor to this growth was introducing pet grooming services after "listening and responding to market demand." On the sale of puppies, Woof Gang representatives have said: "To be perfectly clear, the Woof Gang Bakery company adamantly opposes the archaic and abhorrent practice of puppy mill breeding and selling puppy mill dogs. Good pet stores do not sell puppies and responsible pet breeders do not sell to stores."

Pet Food Express, the $15^{\text {th }}$ largest pet store chain, focuses on "products that meet rigorous quality standards" and "the very best customer service" and proudly partners shelters and rescues to adopt out homeless pets. In a letter to support California legislation to prohibit the sale of commercially raised puppies in pet stores, the owners wrote: "We support AB 485 because we want to see all pet stores operate responsibly. Not only is it the right thing to do, but it's the key to a successful business."

PetSmart and PetCo, the two largest chains, have never sold dogs or cats. Instead, both offer a wide range of products and services and partner with thousands of animal welfare organizations across the nation to showcase adoptable pets. This not only saves lives, but also increases profits for the stores, as adoption event days are often their busiest and most profitable with adopters buying everything they need for their new pet, often spending 5 times more than the average shopper and becoming a loyal customer.

## HUMANE PET STORE ORDINANCE

Background: Selling commercially raised puppies and kittens in pet store raises serious animal welfare and consumer protection issues. By prohibiting pet stores from selling commercially raised dogs and cats but allowing them to partner with shelters and rescues to host adoption events and sell products and services, lawmakers can protect consumers and promote humane businesses.

Nearly 400 localities across 30 states and five states have already enacted this policy.


A humane pet store ordinance will reduce the demand for puppy mill puppies.

- Pet stores can only fill their cages everyday with dozens of 8-week-old puppies of varying breeds by sourcing from large-scale commercial breeders that place profit over the wellbeing of their dogs.
- Public records show the vast majority of puppy-selling pet stores source the majority of their puppies from large scale commercial breeders and brokers, many with egregious animal welfare records.
- Responsible breeders never sell to pet stores because they demand to meet prospective buyers in person and their breed clubs' codes of ethics do not allow it.

A humane pet store ordinance will protect puppies from the puppy mill-pet store pipeline.

- Pet store puppies are born into cruel and unsanitary conditions, taken from their mothers at just 7-8 weeks old, crammed into cages and trucked across the country in close proximity to other stressed and sick puppies, and then placed in pet store cages to be handled by inexperienced staff and consumers.
- Overcrowding, filthy conditions, and lack of basic veterinary oversight at commercial breeding facilities and during transport lead to many health issues once puppies reach pet stores. According to the CDC, $95 \%$ of pet store puppies have been pumped with antibiotics.
- Neither the USDA nor any state agency adequately protect breeding dogs or puppies, and USDA license does not mean a facility is not a puppy mill.

A humane pet store ordinance will protect consumers from a wide range of problems.

- Pet stores charge premium prices for puppies by promising consumers the puppies are from quality breeders, yet if consumers could see the conditions the puppies were born into and transported in, they would overwhelmingly refuse to support that cruelty.
- Pet store puppies are often sick, costing consumers hundreds or thousands of dollars in veterinary bills, and sometimes leaving them with the heartbreak of having a new pet die or having to relinquish them.
- Contact with pet store puppies has led to an antibiotic-resistant disease outbreak that sickened over 100 Americans and led one CDC official to state that "it is difficult to control a whole system that lacks hygiene at many points and seems to use antibiotics instead."
- When consumers balk at the price of puppies, sales staff offer third party financing with low interest rates. Yet, pet store customers have unknowingly ended up with interest rates as high as $188 \%$.

A humane pet store ordinance supports responsible pet businesses and pet acquisition.

- The massive retail pet industry ( $\$ 103$ billion and counting) is dominated by the sale of pet products and services, with dog and cat sales not even tracked anymore after steadily declining for years.
- Stores that have sold puppies in the past are now thriving with a products and services model, with some adding high demand services like grooming, training, or daycare.
- Residents will still be able to obtain the pet of their choice by adopting from a local shelter or rescue or seeking out a responsible breeder who sells directly to the public.


## Humane Pet Store Law FAQ

What will this bill/ordinance do?
It will drive the pet market towards more humane sources such as shelters, rescues and responsible breeders by prohibiting the sale of dogs and cats in pet stores. This is a reasonable restriction that alleviates a wide range of documented problems that stem from the sale of puppies in pet stores.

What problems do puppy-selling pet stores pose?
Animal welfare problems: It is hard to imagine a worse pipeline for an 8-week-old puppy to be immersed. Most pet store puppies are born in cruel and unsanitary puppy mills, taken from their mothers at just weeks old, trucked long distances, and then placed on a pet store sales floor. What pet store customers don't see are the mother dogs languishing in faraway puppy mills, provided bare minimum care to keep them alive and breeding.

Consumer protection problems: Because of the conditions they were born into, overbreeding and inbreeding of their mothers, the stress of transport, and comingling with other sick puppies, pet store puppies are likely to be sick, often costing customers hundreds or thousands of dollars in veterinary costs, sometimes only to suffer the heartbreak of their new pet dying. Because pet store puppies were taken from their mothers and littermates too early and know nothing but life in a cage, they are also likely to have behavior problems. Consumers are also often misled with false promises about a puppy's health, socialization, and the breeder they came from.

Public health problems: According to the American Medical Association and the CDC, pet store puppies continue to expose staff and customers to an antibiotic-resistant strain of Campylobacter. Some patients endured prolonged hospital stays because the infection wasn't treatable with traditional antibiotics. This outbreak is a result of pet stores responding to the high numbers of sick, or likely-to-be sick, puppies with reckless antibiotic overuse.

Predatory lending: Puppy financing options are a key part of the pet store sales pitch, since few can afford thousands of dollars for a puppy out-of-pocket. So, pet stores push financing and promise low or no interest rates. Yet, pet store customers have unknowingly ended up with interest rates as high as $188 \%$, and some have to make payments on puppies that died shortly after purchase.

Why don't responsible breeders sell to pet stores?
Responsible breeders only sell directly to the public so they can screen prospective buyers in person. They would never hand over their puppies to a truck driver to be transported to a faraway pet store, displayed like a product, and sold to anyone with a credit card. Plus, most breed clubs discourage selling to pet stores and pride themselves on selling exclusively to individuals or families they have met.

What impact will this bill have on existing pet stores?
The vast majority of pet stores-both large and small-are already in compliance with this bill as they do not sell puppies. Those that do sell puppies are an outlier in their own industry and are ignoring market trends. Any pet store would be smart to tap into the $\$ 103$ billion pet market that is dominated by the sale of pet products and services. Some puppy-selling pet store owners have claimed puppies are their niche and they need that to compete against other stores. Luckily, those willing to put in the effort to change their business model can find a new niche and thrive.

For instance, Daryl's Pet Store in Redlands, CA has been in business since 1975. After the statewide prohibition on dog and cat sales went into effect, they ramped up their focus on high quality pet supplies and started offering "a full suite of grooming services." Love's Pets in Agoura Hills, CA sold puppies before the law went into effect too. Now they boast on their website: "We have over 30 years of experience providing expert non-veterinary care, grain-free 1st quality food \& treats, nutritional supplements, and pet toys \& accessories." Park Pet Shop was required to stop selling dogs and cats after the Chicago law went into effect, and the store remains open with a products and services model that includes grooming and aquarium services.
What impact will this bill have on the puppy mill industry?
It is well-documented that most pet store puppies come from puppy mills. Basic principles of supply and demand dictate that if pet stores no longer buy puppies from mills, that inhumane marketplace will shrink and less dogs will be forced into a life of confinement to be bred repeatedly. Also, a report on dog breeders from IBISWorld Industry found that
"adopt don't shop" campaigns and a steadily declining number of pet stores working with breeders has led to decreased revenues for breeders. The report notes an additional benefit-when low-quality breeders are forced out of the industry, the overall quality of breeders will slowly improve and eventually there will be far less puppy mills and far more reputable breeders. Although the impact of pet store ordinances on the puppy mill industry is less traceable and more gradual than many would like, it is crucial to note that $100 \%$ of the consumer protection issues that pet stores pose go away when stores stop selling puppies.

What impact will this bill have on unscrupulous rescues?
Most rescues operate responsibly while doing the lifesaving work of rehoming animals. At the same time, puppy mills churn out as many puppies as possible with no regard for the health and wellbeing of their breeding dogs or their offspring, nor for the public who will end up with unhealthy pets. Under this bill, pet stores would be allowed to partner with rescues to host adoption events, as this has been proven to drive consumers to stores, but stores have total control over which rescues they work with or if they work with rescues at all. Focusing on rescues is merely an attempt to deflect attention away from the massive puppy mill problem.

What does a USDA license say about the quality of a breeder?
A USDA license says almost nothing about the quality of a breeder, as standards are shockingly low and enforcement is severely lacking. Pet stores that brag about sourcing from USDA-licensed breeders apparently feel it is acceptable to confine dogs in stacked, wire cages only six inches larger than themselves for their entire lives, denying them exercise and basic veterinary care, and breeding them at every heat cycle until their bodies wear out, as all of this is allowed under federal law. Many licensed breeders fail to even meet the low standards, yet the USDA continues to license them year after year. In recent years, the USDA has proven it cares far more about protecting the puppy mill industry than regulating it, with policies that instruct inspectors to avoid citing for most violations of the Animal Welfare Act.

Where can people obtain the dog of their choice if not from a pet store?
According to the pet industry, only $4 \%$ of dogs are obtained from pet stores, so no significant impact on consumer choice will be felt. People can still adopt from a shelter or rescue or purchase a puppy from a responsible breeder who happily allows consumers to see where the puppy was bred and raised. A search of the AKC Marketplace, for instance, shows there are many puppies of popular breeds available in the area from breeders that consumers can meet in person.

Are pet stores a regulated outlet for puppy-buying consumers?
There are minimal legal protections for pet store animals and consumers. Few states regulate the source of pet store puppies - the root of all problems with puppy-selling pet stores. No state or locality has the authority to regulate breeders and dealers in other states. The federal government does not regulate pet stores, and its regulation of commercial breeders is minimal at best.

Why don't pet store laws increase "black market" online puppy sales?
Even though the USDA has been regulating those who sell puppies over the internet for the past 8 years and breeders who sell online face the same regulation as those who sell to pet stores, puppy-selling pet stores continue to argue that online sales are a "black market." Also, there is no evidence that pet store laws have led to increased online puppy sales. For one, pet store customers want to meet a puppy in person before purchase, so they are more likely to seek out a responsible breeder or a shelter or rescue than buy a puppy sight-unseen online. Also, pet stores cater to impulse purchases. Without that cute puppy in the window in high foot traffic areas, many wouldn't buy a puppy at all.

Dear Commissioner Justice:

I am the founder and president of Companion Animal Protection Society, which investigates the pet shop and puppy/kitten mill industry. Founded in 1992, CAPS understands every aspect of this cruel industry, which not only abuses and exploits animals but commits consumer fraud and misrepresentation.

Our investigators have gone undercover to more than 1,000 mills, most of them USDA-licensed, and to hundreds of pet shops around the country, including many in Florida. They've also worked undercover at the largest USDA licensed broker in the country, the most notorious broker/breeder, who had 900 adult dogs and 400 puppies (she was convicted and lost her USDA license based on our evidence), and two Petland stores. The investigative evidence for one Petland was featured in the hour-long story we did with Dateline in 2000; this exposé took us 13 months to produce.

CAPS has investigated USDA and compared our findings to those of USDA inspectors, which is why we were able to get a meeting with USDA's Office of Inspector General in 2006 through our pro bono lobbyists in Washington, D.C. The result of this two-hour meeting was a scathing OIG report in 2010. USDA encourages inspectors to not find violations or to write them up as teachable moments that don't appear on reports. When pet shops tell you their breeders have no violations, it means nothing. We are now gathering state inspection reports that have multiple violations for the same facilities that have no federal ones

Our West Hollywood ordinance, passed in 2010 was the genesis for the pet shop ordinance movement. CAPS was behind the Sarasota ordinance and trained the advocate who subsequently got ordinances passed in Manatee, Hillsborough and De Soto Counties.

Yesterday, New York passed a statewide retail ban law, which we had been trying to pass for four years after having investigated the 100 (now 58) pet shops in the state, many multiple times, and numerous puppy/kitten mills selling to them.

Here is the blog and video expose about the four Pinellas pet shops selling puppies and the one selling rabbits, birds, chicks and ducks that were open in August 2021. As you know, two more puppy selling pet shops subsequently opened. After reading the blog and watching the video exposé, if you aren't convinced that banning the retail sale of dogs, cats, and rabbits is the ethical decision, then I will be happy to email you the full-length investigation reports. Hillsborough
realized that grandfathering in pet shops doesn't work. All about Puppies and Puppies Tampa (arrested for not using CVIs) have the same owners as your All about Puppies and Puppies St. Pete.

Maybe it doesn't bother you that the puppies being sold in your county's pet shops are raised in puppy mills. But you should be concerned about your citizens being deceived. Our investigations of pet shops are primarily about exposing the fraud and misrepresentations being told by owners, managers and employees. We also documented that Sunshine Puppies isn't complying with Largo's regulatory ordinance by failing to disclose breeder addresses and USDA numbers on cage cards.

The pet shops in your county use the same brokers and breeders as other pet shops in Florida. After Pinellas, our investigator went to the three pet shops in Lee County and six puppy stores and one rabbit and bird store in Miami Dade. Miami-Dade has 23 pet shops selling puppies, down from the 27 we investigated in 2018. The owner of Petland Largo also has franchises in Plantation, Pembroke Pines, Davie, Naples, Kendall, and Doral (opened in September 2021), four more in Texas and one in Kansas.

Dear Commissioners,
I have been a Pinellas resident and voter since 1999. I founded 501c3 non-profit animal rescue, Rescue Pink, and am a longtime volunteer at Pinellas County Animal Services and Humane Society of Pinellas.
I spoke with most of you on the phone on this topic a few months ago. Since then, it was a positive step (thank you!) that we passed a ban on no new retail pet stores allowed (thankfully since we have more than most counties in the state).
Unfortunately, grandfathering these 6 stores means business continues as usual in Pinellas County when all the surrounding counties have banned them.
I met a woman this week and found out she bought her 'Shih Tzu' from Sunshine puppies. \$2,600 later, she found out the dog is not a purebred Shih Tzu. It looks more like a poodle mix yet they posted the 'mom and dad' on the cute little book they gave her, showing her dog also. You can see even then it doesn't look like a Shih Tzu (I have 2 rescue Shih Tzu's from PCAS and I can attest the dog is not a purebred Shih Tzu). I am attaching the Certificate of Veterinary Inspection showing the dog came from Missouri, which of course is no surprise since these stores buy from puppy mills. I am also attaching their cover and a picture of the dog. Their warranty is a joke and they will not cover practically anything. They even mention if the dog is not the breed it states, they won't do anything.
There is little consumer protection at these stores and solid proof these pups come from puppy mills. The county presentation for the retail pet store meeting on $6 / 7$ gives so much good information about the lack of regulation of these puppy mills and states:

Dear Commissioners:
ASPCA has worked across the country to support the passage of effective state and local laws aimed at shutting down the puppy mill pipeline that supplies pet stores with inhumanely bred puppies. On behalf of our Pinellas County supporters, we are writing to urge the County to reject the proposed changes to Chapter 14 of the Pinellas County Code to grandfather existing stores and restrict the expansion or relocation of existing stores. Such changes fail to protect animals or consumers from the inherent problems associated with sales of puppies in retail stores. Instead, we encourage the County to adopt an ordinance that definitively ends the retail sale of dogs and cats in Pinellas County. Grandfathering existing operations would have no impact on the puppy mill pipeline that imports cruelly bred dogs from commercial dog breeding operations into Pinellas County for sale in retail stores.

Dogs in commercial breeding facilities spend most of their lives in cramped cages, where they are made to produce litter after litter and suffer from inadequate care. A pipeline of middlemen ships puppies from out-of-state puppy mills to Florida, where they are sold on to an unsuspecting public. Responsible breeders do not sell their puppies or kittens to pet stores for resale. By ending the sale of dogs in stores, the Board can shut down the puppy mill pipeline into Pinellas County. Pet businesses in Florida that do not sell dogs far outnumber pet stores that do, demonstrating that stores do not need to sell dogs to thrive.

ASPCA asks the Board to reject the current proposal and instead move forward with an ordinance that clearly prohibits the retail sale of dogs and cats and does not grandfather existing stores. Adding an amortization period of one year or less would allow stores to adapt their business model.

As we have seen first-hand, pet dealers will exploit poorly crafted language to continue selling puppy mill dogs. ${ }^{[1]}$ The ASPCA strongly recommends that any law that addresses pet store sales definitively prohibit all retail sales of dogs and cats, without grandfather provisions or loopholes that permit stores to sell dogs obtained from certain sources. An effective model permits pet stores to partner with shelters and rescues to provide space in their stores to display
adoptable animals, while ownership remains with the partnering non-profit or governmental organization. This is the model that many retail pet stores currently employ to great success and is the only model the ASPCA supports. It is the most effective way to prevent puppy mill cruelty and safeguard public health and consumers.

In sum, we urge the Board to adopt an ordinance that clearly and fully prohibits the sale of dogs and cats in pet stores. I have enclosed additional materials, including model ordinance language and a report that traces the source of pet store puppies in Florida. # FLORIDA'S PUPPY MHLI PIPELTNE: 

 TRACING THE SOURGE OF PET STORE PUPPIES

## INTRODUCTION

## A pipeline of out-of-state commercial dog breeders and middlemen moves truckloads of puppies to be sold in Florida's pet stores.

Commercial breeders (a.k.a. puppy mills) profit by producing large numbers of puppies as quickly and cheaply as possible. Dogs are forced to live in cramped, filthy cages where diseases spread easily. Dogs receive minimal veterinary care and are forced to breed nonstop-even if they are sick, weak or have serious hereditary issues that could be passed on to their offspring.

The conditions in which these dogs are kept would be unacceptable to almost anyone. But these facilities aren't opening their doors to consumers. Instead, they ship their weeks-old puppies to pet stores or employ a network of brokers or middlemen to traffic puppies to pet stores in faraway states, where they are marketed as "responsibly bred" puppies from trusted breeders. The harsh transport conditions endured by these very young puppies can also invite the spread of disease, resulting in sick and dead puppies. This cruel system obscures transparency and traceability resulting in compromised puppies being sold to unsuspecting consumers throughout Florida.

## METHODOLOGY

Through monthly public records requests to the Florida Department of Agriculture and Consumer Services/Public Records Division (FDACS), the ASPCA received over 5,000 puppy import records (i.e. Certificates of Veterinary Inspection, or CVIs) for the period of August 2019 through December 2020. According to Florida law, an Official Certificate of Veterinary Inspection is required to be filed for all dogs imported into the state intended for sale. The CVI document includes information such as the age, sex, breed, color, and health record of the dog, the names and addresses of the consignor or seller and the consignee or purchaser.

The ASPCA analyzed these 5,000+ import CVIs provided by FDACS, which details imports of over 12,000 puppies over the aforementioned period. ${ }^{1}$

## KEY FINDINGS

- Over $\mathbf{8 0} \%$ of the puppies imported into Florida came from only 5 states: Missouri, Indiana, Ohio, Iowa, and Kansas. These midwestern states have the highest concentration of commercial dog breeding facilities in the U.S. ${ }^{2}$



#### Abstract

- More than 6,500 (53\%) of all puppies shipped into Florida were from commercial puppy brokers who function as "middlemen" in the puppy mill pipeline. When looking at the top 25 suppliers, 86\% of pet stores imported puppies from brokers and they were 4 times as likely to be sourced from a broker than a breeder. - Blue Ribbon Puppies in Indiana is the single largest supplier to Florida pet stores. The Centers for Disease Control (CDC) linked this puppy broker to a major multi-drug resistant disease outbreak, caused by contact with puppies sold at pet stores. According to the CDC, Florida had the second highest number of campylobacter infections nationally. ${ }^{3}$ Blue Ribbon Puppies was a major supplier of Petland stores in Florida, and shipped to locations in Largo, Plantation, Pembroke Pines, Davie, Naples, Kendall, Fort Walton, Orlando, and Pensacola. Blue Ribbon Puppies also shipped puppies to Palm Beach Puppies and Nessy's Puppies of Kendall.

[^2]- Two major suppliers to Florida are also commercial brokers: J.A.K.s Puppies in lowa and Sobrad LLC d/b/a Pinnacle Pet in Missouri. In 2019, J.A.K.s Puppies, along with another lowa- based business, was sued by the lowa Attorney General for illegally transferring hundreds of designer puppies through sham lowa non-profit "rescues" to out-of-state pet shops. The lawsuit accused J.A.K.s Puppies of misleading consumers about the true source of the puppies and for abusing their lowa non-profit status to circumvent state and local laws banning the sale of "puppy mill"
J.A.K.s Puppies supplies puppies to over a quarter of Florida's puppy-selling pet stores. dogs. In 2020, lowa dissolved J.A.K.s Puppies' phony rescue, Hobo K-9, and imposed a $\$ 60,000$ penalty against them. ${ }^{4}$ J.A.K.s Puppies remains federally licensed to broker puppies. J.A.K.s Puppies supplied to Bff Puppies, Breeders Pick, Chews A Puppy, Diamond \& Doggies, Forever Love Puppies, Furbabies at the Mall, Glamorous Puppies, Love My Puppy, Nessy's Puppies of Kendall, Pet Kingdom, Petland Bradenton, Petland South Orlando, Puppies and Rescues, Puppies Galore \& More, Puppies To Go, Puppy Avenue, Puppies Secret and Vanity Pups.

## A SAMPLING OF COMMERCIAL BREEDERS SUPPLYING FLORIDA PET STORES

## Joyce Cairns (Kansas)

This facility has over 160 dogs with a history of USDA violations, including dogs with dental disease, heavily matted and dirty coats, jagged metal enclosures, screws protruding at dogs' eye level, contaminated feeders, floors wet and soiled with feces (resulting in "soiled dog coats"), a dog with hair loss and exposed skin that was "thick and scaly," a dog with green eye discharge, and a dog who was very thin with the spine "visually protruding." Pictured below are photos of dogs in this facility at a USDA inspection in 2020. Cairns supplied puppies to Puppies Secret, Puppies To Go, Palm Beach Puppies, Gorgeous Puppies and Kittens, Puppies World of Miami, Imperial Puppies, Beautiful Puppies \& Boutique and Nessy's Puppies of Kendall.


## Lorilee Thomas/Puppies Extraordinaire (Kansas)

This operation has over 1,000 dogs and a history of USDA violations, including dogs with hair loss, dogs with matting, eye injuries, wires poking into kennels, excessively long toenails, and evidence of mice. Thomas supplied puppies to All About Puppies Largo, All About Puppies Tampa, Breeders Pick, Gorgeous Puppies and Kittens, Imperial Puppies, Lil Rascals Puppies, Petland Fort Walton, Petland Pensacola, Puppies To Go and The Puppy Store.

## Justin and LaNae Jackson (Kansas)

This commercial operation has almost 600 dogs at their facility. The USDA has cited many violations, including both underweight and sick dogs, rusty kennels and broken floors, limited shade and shelter in housing, grime and rust in the feeders, dog with open ear wound, dog with swollen mass in between toes, and expired medication. Pictured below are dogs at this facility at a USDA inspection. This breeding operation supplied puppies to Sunshine Puppies, Puppies To Go, Nessy’s Puppies of Kendall, Breeders Pick, Puppies Secret, Chews A Puppy, Beautiful Puppies \& Boutique, Epic Puppies, Palm Beach Puppies, Glamorous Puppies, Puppies World of Miami, Gorgeous Puppies and Kittens, Quality Doggies, Imperial Puppies and Lil Rascals Puppies.


## CONCLUSION

Insufficient laws, coupled with the USDA's neglectful enforcement of its bare-bones welfare regulations, have proven to enable massive animal suffering. The cruel puppy mill pipeline is bringing puppies into Florida at an alarming rate, where they are sold to an unsuspecting public. By ending the sale of dogs in stores, we can shut down the puppy mill pipeline into Florida.

## ASPCA Model

## Section 1. PET SHOPS

## A. Definitions

As used in this Article, the term:
(1) "Animal care facility" means an animal control center or animal shelter, maintained by or under contract with any state, county or municipality, whose mission and practice is, in whole, or in significant part, the rescue, care, and placement of stray, abandoned, or surrendered animals in permanent homes or with rescue organizations, and which does not breed animals.
(2) "Animal rescue organization" means any not for profit organization which has tax exempt status under Section 501(c)(3) of the United States Internal Revenue Code, whose mission and practice is, in whole or in significant part, the rescue, care, and placement of stray, abandoned, or surrendered animals in permanent homes, and which does not breed animals.
(3) "Cat" means a member of the species of domestic cat, Felis catus.
(4) "Dog" means a member of the species of domestic dog, Canis familiaris.
(5) "Pet Shop" means a retail establishment where animals are sold, exchanged, bartered, or offered for sale as pets to the general public at retail. Such definition shall not include an animal care facility or animal rescue organization, or a person or establishment that sells, exchanges, barters, or offers for sale only animals that were bred or reared on the premises of such person or establishment.

## B. Restrictions on the Sale of Animals

A pet shop may not sell, exchange, barter, offer for sale, auction, or otherwise deliver or transfer a cat or a dog, provided that nothing in this section shall prevent a pet shop from providing space and appropriate care for cats and dogs owned by an animal care facility or an animal rescue organization and maintained at the pet shop for the purpose of adopting those animals to the public.

## C. Disclosures

A pet shop that provides space for the adoption of cats or dogs shall post, in a conspicuous location on the cage or enclosure of each such animal, a sign stating the name of the animal care facility or animal rescue organization which owns the dog or cat offered for adoption.

## D. Offenses

Each dog or cat sold, exchanged, bartered, offered for sale, auctioned, delivered, or transferred in violation of this section shall constitute a separate offense. Each failure to post a sign for an individual dog or cat as required by this section shall constitute a separate offense.

RE: Proposed changes to ordinance will not address problems with sales of puppies from puppy mills

Dear Commissioners:

ASPCA has worked across the country to support the passage of effective state and local laws aimed at shutting down the puppy mill pipeline that supplies pet stores with inhumanely bred puppies. On behalf of our Pinellas County supporters, we are writing to urge the County to reject the proposed changes to Chapter 14 of the Pinellas County Code to grandfather existing stores and restrict the expansion or relocation of existing stores. Such changes fail to protect animals or consumers from the inherent problems associated with sales of puppies in retail stores. Instead, we encourage the County to adopt an ordinance that definitively ends the retail sale of dogs and cats in Pinellas County. Grandfathering existing operations would have no impact on the puppy mill pipeline that imports cruelly bred dogs from commercial dog breeding operations into Pinellas County for sale in retail stores.

Dogs in commercial breeding facilities spend most of their lives in cramped cages, where they are made to produce litter after litter and suffer from inadequate care. A pipeline of middlemen ships puppies from out-ofstate puppy mills to Florida, where they are sold on to an unsuspecting public. Responsible breeders do not sell their puppies or kittens to pet stores for resale. By ending the sale of dogs in stores, the Board can shut down the puppy mill pipeline into Pinellas County. Pet businesses in Florida that do not sell dogs far outnumber pet stores that do, demonstrating that stores do not need to sell dogs to thrive.

## ASPCA asks the Board to reject the current proposal and instead move forward with an ordinance that clearly prohibits the retail sale of dogs and cats and does not grandfather existing stores. Adding an amortization period of one year or less would allow stores to adapt their business model.

As we have seen first-hand, pet dealers will exploit poorly crafted language to continue selling puppy mill dogs. ${ }^{1}$ The ASPCA strongly recommends that any law that addresses pet store sales definitively prohibit all retail sales of dogs and cats, without grandfather provisions or loopholes that permit stores to sell dogs obtained from certain sources. An effective model permits pet stores to partner with shelters and rescues to provide space in their stores to display adoptable animals, while ownership remains with the partnering non-profit or governmental organization. This is the model that many retail pet stores currently employ to great success and is the only model the ASPCA supports. It is the most effective way to prevent puppy mill cruelty and safeguard public health and consumers.

[^3]In sum, we urge the Board to adopt an ordinance that clearly and fully prohibits the sale of dogs and cats in pet stores. I have enclosed additional materials, including model ordinance language and a report that traces the source of pet store puppies in Florida. Good afternoon,
I have lived in Pinellas County for 30 years. I volunteer at two No Kill Shelters. I've done this for 20 years. I've also participated in raids on puppy mills. The things I have witnessed are beyond comprehension. I've attended seminars numerous times on this issue.
True licensed, registered breeders explained that their dogs never go to stores that sell pets. One very clear way of knowing this and proving this was what they stated.
A breeder want to keep the line "pure" according to AKC regulations. If a dog has a trait, or is missing a trait that is required, they do not want that dog to reproduce. They will spay or neuter the dogs and place them in homes. At times they do take a fee. They pointed out that dogs sold in stores are almost never spayed or neutered. There are unscrupulous back yard breeders and puppy mill people who will mate a father and pup or a mother and pup if they think it will bring a more desirable color, more puppies to the litter etc. They have Veterinarians who stamp medical certificates en-masse for the dogs to travel interstate. When the dogs show signs of illness due to in breeding and poor care, the Vet having signed the certificate responds and says when they saw the dog, there were no issues. They have no idea what happened after that.
I myself have adopted two Double Dapple Dachshunds. At first I'd never heard of them. I'm quite familiar with them now. If you mate two Dapples, and they are Dachshunds that have spots on a dark coat, mating two provides a dog that has a white body, back legs that look like they are wearing little black pants, and often there are leopard spots in their ears. They are adorable and irresistible. However, almost all are born blind and deaf. It's impossible for a buyer to determine if a puppy is blind or deaf. Most of these dogs are born without legs, or
very deformed bodies. The backyard/puppy mill breeder will snap their necks or just drown them as they know they can't even let them be seen. My last double dapple was born to a puppy mill in Savannah Georgia. She was blind and deaf. A young girl working there fell in love with the dog and asked her boss not to drown the dog. She would adopt it. He gave her 24 hours to get approval from her parents. They refused. This girl was resourceful. She has witnessed things no one should ever have to see. She called D.A. R. E. They drove all night to pick up the dog from Savannah, hence her name.
I adopted this dog. She could see some shadows, that was it. I loved her with all my heart. She died at a young age due to other congenital issues from the inbreeding. Because they look a little cuter, a little different, a breeder can charge a few dollars more, are we going to allow this?
People are under the misconception that with a store bought dog, they will know what they're getting. They don't realize what is behind this.
I beg you to do all that you can to eliminate these stores from selling puppies. A true licensed breeder will still be able to offer people the puppies they want. They will be healthy puppies and lead healthy lives hopefully. I've seen first hand people turning in dogs to shelters that they paid thousands of dollars for. Often the dogs have epilepsy. Often they realize they are blind, deaf or impaired. The store wants nothing to do with that. A true breeder as well as all shelters and rescues that I know of, in their contract, insist that you return the dog to them if there is any issue. Do not pass the dog along to a friend or relative.

These stores outfit themselves to look like a nursery and the sales people are Mary Poppins. Nothing could be further from the truth.
Growing up, a mixed breed dog was a Mutt. In my opinion, the greatest dogs. Now they are called "designer breeds".
What has happened to us here? These mills mate a Maltese with a Bichon because they're both white, a Bichon is a bit larger. They mate them in the hopes of having 3-5 puppies in a litter as opposed to 2-3. I've seen kennels stacked on kennels being hosed down with the dogs in them. The food and water bowls are in them, the dogs in terrible condition. There is no care or concern for the dogs used to breed. The only concern is how many puppies they can remove from a cage.

There is no way to control this behavior. If they are raided, the purpose is to save the dogs. If the people are given a summons, unless they surrender the dogs, they can't be taken away. As the point is rescuing them, they don't issue them a summons as long as they relinquish the dogs. Those dogs are saved. However, the puppy mill will re-open either in the same spot or a couple of miles away.

Let people have the puppies they want. Let them buy instead of adopt if that 's what they want. Personally, I'm in favor of adopting dogs. They know you've given them a second chance
at life. You will never have a more devoted pet. Ask anyone who has adopted from a reputable shelter or rescue.

Please stop the horrors that are created to keep these puppy stores in business. We are a humane people in a humane society. There is no need for this to continue. However, until the money is taken out of it, the stores will continue to take puppies from anywhere. And in these cases, "anywhere" is a puppy mill.

These puppy mills are as horrifying as concentration camps. They are about torture and death. How can we stand by and let this continue?

Please do everything you can to eliminate this horrible situation.

Dear Honorable and Distinguished Members of Pinellas County Commission: I write you today as president of MEOW Now Inc. (501-c-3). I am asking you to rethink your position if you are in favor of this proposed ordinance. The animal welfare community at large opposes this proposed ordinance for one simple reason; it allows "grandfathering" of the current retail pet stores. The USDA Inspector General cited a number of deficiencies in this oversite department like:

## Minimal standards in place and minimal enforcement

- Enforcement process was ineffective against large-scale dog dealers
- Inspectors did not cite or document violations properly
- The APHIS penalty worksheet calculated minimal penalties
- APHIS misused guidelines to lower penalties
- Some breeders circumvented the AWA by selling animals online
- Minimal Work is being done to enforce the AWA
- Lack of organization by the USDA


## The report went on to further say:

In 2021 the IG summary stated:
"We found that APHIS did not consistently address complaints it received or adequately document the results of it follow up. This occurred because APHIS does not have a documented process for resolving complaints and recording the results of the agency's actions. As a result, some dog breeder facilities may be conducting regulated activity without a USDA license or oversight."

## USDA license or oversight. Therefore, APHIS is not able to ensure the overall health and humane treatment of animals at these facilities."

Commissioner's, please take a look around at our neighbor counties and cities. A total ban has been approved over and over again. Why does Pinellas County stand alone? Frankly, you all asked animal services to research this issue and report back. Animal services did and came to a conclusion that "grandfathering" would not solve the problem. So, I ask, who is it that seemingly pushed for the "grandfathering" clause in the final draft? This "grandfathering" ability will continue to create cruelty allowing people from the banned communities to come to Pinellas to purchase a dog. Do we want to be viewed as supporting "wholesale breeders" who by your own research finds significant risk of cruelty and inhumane treatment of these dogs? Were better than that! It pains me to think that this honorable group of elected officials are willing to and would be supporting the inhumane treatment of dogs and cats in our community.

I respectfully ask you to amend the ordinance that will ultimately ban retail pet sales in our county. Thank you for reading my letter and thank you for your public service!

I appreciate your consideration of a ban on retail sales of rabbits in your County. There are multiple reasons for a ban both humane and monetary. Pet Co and PetSmart stopped selling rabbits over 14 years ago, not for humane reasons but because of profits. To get baby bunnies, they must be pulled early from the mother. The transport method and time to stores results in up to $30 \%$ losses to death and disease. Up to $60 \%$ never get sold because the cute bunny stage does not last long. These stores changed because they knew the real money was in selling supplies, feed, toys and housing.

Rabbits tend to be an impulse buy, thought of as an "easy" first pet. With no previous education, quickly owners learn about higher maintenance costs than a dog or cat. Not all vets care for rabbits, so it is expensive up to $\$ 150-200$ just to be neutered. Rabbits may already be pregnant when adopted! They also need to get nails clipped, teeth ground down coupled with respiratory and gastrointestinal diseases are common. You cannot just give them kibble like dog or cats; pellets alone are insufficient.

When the child loses interest in the rabbit, they often put them outside in a hutch on wire their feet cannot tolerate, with temperatures too cold in the winter and too hot in the summer and prey for insects and predators.

People quickly tire of the "carefree" rabbit as too much work, too much money, too much time and unlike their dog or cat feel okay about abandoning them outside. They see wild rabbits and assume they can survive just like them which is far from the truth. They are the third most abandoned pet because public shelters do not take rabbits for the same reasons owners give them up, they are not nearly as easy to care for as dogs and cats! The rescues are overwhelmed and have to turn them away.

You will notice, I have not even mentioned the inhumane rabbit mills where their life began. These "bunny" mills are similar to puppy mills but the standards are only one square foot per rabbit. The females are bred at every heat with up to 12 offspring in the 8-10 litters a year. Unlike dogs, rabbits are also raised for meat, fur, hunting and cosmetic testing. They are social animals with different personalities, likes and dislikes just like any other pet.

There are currently three locations in Florida which have placed bans on retail sales of rabbits, Orange County, DeSoto County and Key West. They have all placed rabbits along with dogs and cats in their retail sales ban. Key West simply added rabbits to their definition of pets. Similar to retail bans for dogs and cats, they allow sales from shelters and rescues. This ban will take the pressure off rescues, removing the guilt of turning them away and negating the need for owners to dump them.

Just like any other pet, they need our protection. We can stop selling rabbits from "bunny mills" and allow these stores to only adopt out the rabbits that are filling rescues. By simply adding rabbits to the dogs and cat retail sales bans, we can end the thousands of lives lost every year. It is only the right and humane thing to do.

As a USDA Accredited veterinarian for over 33 years, I believe my perspective on sales of pets in store is relevant. There are some critical factors in this equation that are necessary to evaluate and I will elaborate them for you.

USDA Animal Welfare Rules and Regulations:

1. The term "puppy mill" is primarily based on large scale USDA licensed operations where animals are numbers and not individuals i.e., "factory farming" pets
2. Inspections have been reduced, including post violation follow ups and have not been annual
3. The required husbandry is horrifically minimal as follows:

- Enclosures are only 6 " longer and taller than the animal; allowing only for the ability to stand, turn and lay down
- They must be exercised regularly (who checks?) but not if the solitary animal has twice the minimum cage space or is housed in a group
- It is suggested they have human contact if solitary but can squeeze up to 12 animals in one cage
- Temperatures can be up to $85^{\circ} \mathrm{F}$ and down to $50^{\circ} \mathrm{F}$ before supplemental measures are necessary
- Wire flooring is approved as long as a paw would not fall through; sand, gravel or dirt are approved as long as it is kept "clean"
- Food offered at least once daily unless self-feeders are provided
- Water must be provided twice daily for one hour unless a self-waterer is available
- To maximize profits females are bred at every heat until no longer capable then euthanized.

So, dogs with self-feeders, self-waterers and housed on dirt or wire with other animals require no human contact! What the majority of the pet owning public would consider cruel and inhumane is perfectly legal and "licensed".

American Kennel Club:

1. AKC claims to work to advance canine health and well-being by setting breed "standards" which are frequently detrimental to both confirmation and health.

2. Some obvious examples:
a. Brachycephalic syndrome (bulldogs, pugs, boxers, Boston terriers, Shih Tzu, Pekingese) is a pathologic condition which consists of stenotic nares, elongated soft palette, hypoplastic trachea, making it difficult to breath and surgical correction is often needed

3. Not for profit: when the AKC came out against the ban on racing Greyhounds in Florida, I was shocked until I found out the reasoning. Every greyhound puppy born was registered and paid to the AKC.
4. Registration is based only on the owner's word and regardless of the temperament or health of the animal.
5. The cost to register a dog: Basic: $\$ 35$; Silver: $\$ 50.99$; Gold: $\$ 63.99$. Every puppy born in a USDA breeding facility is registered with the AKC with greater than 600,000 dogs a year, this is $>80 \%$ of their revenue!
6. AKC inspections are not annual. Breeders with $4-6$ litters per year are inspected only randomly. Inspections for breeders with 7-24 litters per year are performed every 18 months with an extra grace period of 18 months for those with two positive inspections in a row. So, there could be up to 36 months between inspections.

## Pet stores:

1. The majority of pet stores no longer sell dogs and cats, if anything they sell birds, reptiles and pocket pets. The larger franchises open themselves to rescue groups providing a space to showcase animals.
2. These stores still employ thousands of people and are obviously successful selling pet supplies.
3. It is ideal for the purchaser of a purebred animal to see both parents for temperament and health concerns which is impossible at a pet store. A responsible local breeder would never send their puppies or kittens to a pet store, rather they want to meet and screen all adopters.
4. The pet stores typically have a "money back" guarantee but know they are feeding on the guilt that results in the reluctance to "return" a sick animal to the store and trade it in for a "new" one. $\qquad$ .these are living, loving beings NOT a broken toy.
5. We cannot stop the reprehensible large scale breeding methods used until we stop buying the puppies. It is a simple matter of supply and demand, if there is no demand for these mass-produced dogs then the supplier's market will dry up and only then will they stop.
6. A very significant concern has been the rise of antibiotic resistant strains of Campylobacter jejuni as a public health threat with a known 168 cases linked to pet store puppies.

## Importation of animals:

1. Importation of animals from other countries can pose a problem with disease and parasites but the number of animals is insignificant compared to those coming from large scale breeding operations.
2. In the south, including Florida, the movement of animals is primarily out-of-state to the Northeast and Midwest where they do not have the high euthanasia rates seen in southern county shelters.

Roughly six million animals go into shelters each year in the US alone; over one million cats and dogs are euthanized and approximately $80 \%$ were healthy adoptable pets and up to $25 \%$ recognized as purebred. Several pet stores stopped selling puppies and kittens years ago, now it is time for the rest of them to do the honorable thing also. This is not a County putting people out of business but the end of an antiquated method of pet sales. Just like the circus has stopped doing animal acts and Sea World has stopped the breeding and shows with Orcas, the public can no longer justify or tolerate the methods being used towards animals in the $21^{\text {st }}$ century. All the big pet stores are still in the billion-dollar business of selling pet supplies.

As a veterinarian who has seen the horrors of the suppliers, I strongly recommend your County moves forward with the humane and moral decision for "man's best friend" and prohibit all retail sales of commercially bred dogs and cats for both new and current facilities.

If the store offers grooming I will come back for that as well. If things work out well I may eventually come back for a companion for fluffy. This model has served Petsmart well for many years.
So let's clear the shelters first, let's get every stray off the streets and into loving homes, let's be ethical in our treatment of the creatures we share this earth with. Let us be the Good Shepards we are meant to be. Let us enforce this ban....

Over and over, well-meaning people fall for rabbits without understanding the time and cost involved. They live 8 to 12 years. They need special foods and plenty of space to run and play in order to be happy and healthy. They need exotic vet care, which can be costly. They need to be fixed - to keep the population in check but also for their health and to keep their hormones under control. Over and over, people realize that buying a pet rabbit was the wrong choice for them - and then they find out that rehoming their rabbit is very difficult. The rabbit rescues are bursting at the seams (all around our state and beyond), and many animal services departments are not equipped to help rabbits. The SPCA in Pinellas took in roughly 300 unwanted pet rabbits in 2019, 246 rabbits in 2020, and 311 rabbits in 2021. And turned away many more! Over and over, people take the easy way out and dump their pet rabbits on the street or in parks, where they suffer unimaginably. Domestic rabbits aren't the same as wild rabbits and are not equipped to live in the wild. They get attacked or killed by predators, hit by cars, infested with bot flies or parasites and often go on suffering with painful injuries or diseases so gruesome that it hurts to look at them. A full retail ban that includes rabbits is the first step in breaking this cycle of cruelty. Passing this ban is the humane choice and the necessary action to take. |
