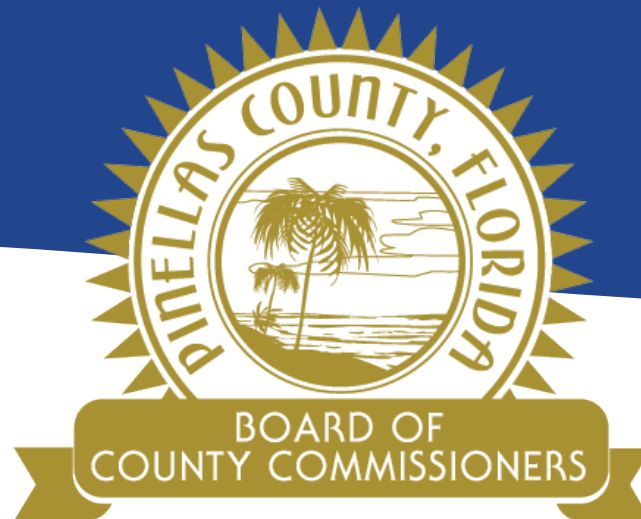

Governmental Capital Improvement Program (CIP)

Capital Projects Fund

- Non-Enterprise
- Penny-Funded Projects
- Tourist Development Tax/Beach Nourishment Projects
- Local Option Fuel Tax/ATMS Projects

Six-Year Plan Updated Annually

- First year (FY23) must be balanced
- Out years are financial/production plan

Penny for Pinellas



1% Local Government Infrastructure Sales Surtax

- Since 1990
- 2017 Approved by 83% of voters
- Jan. 2020 – Dec. 2029

Countywide Investments

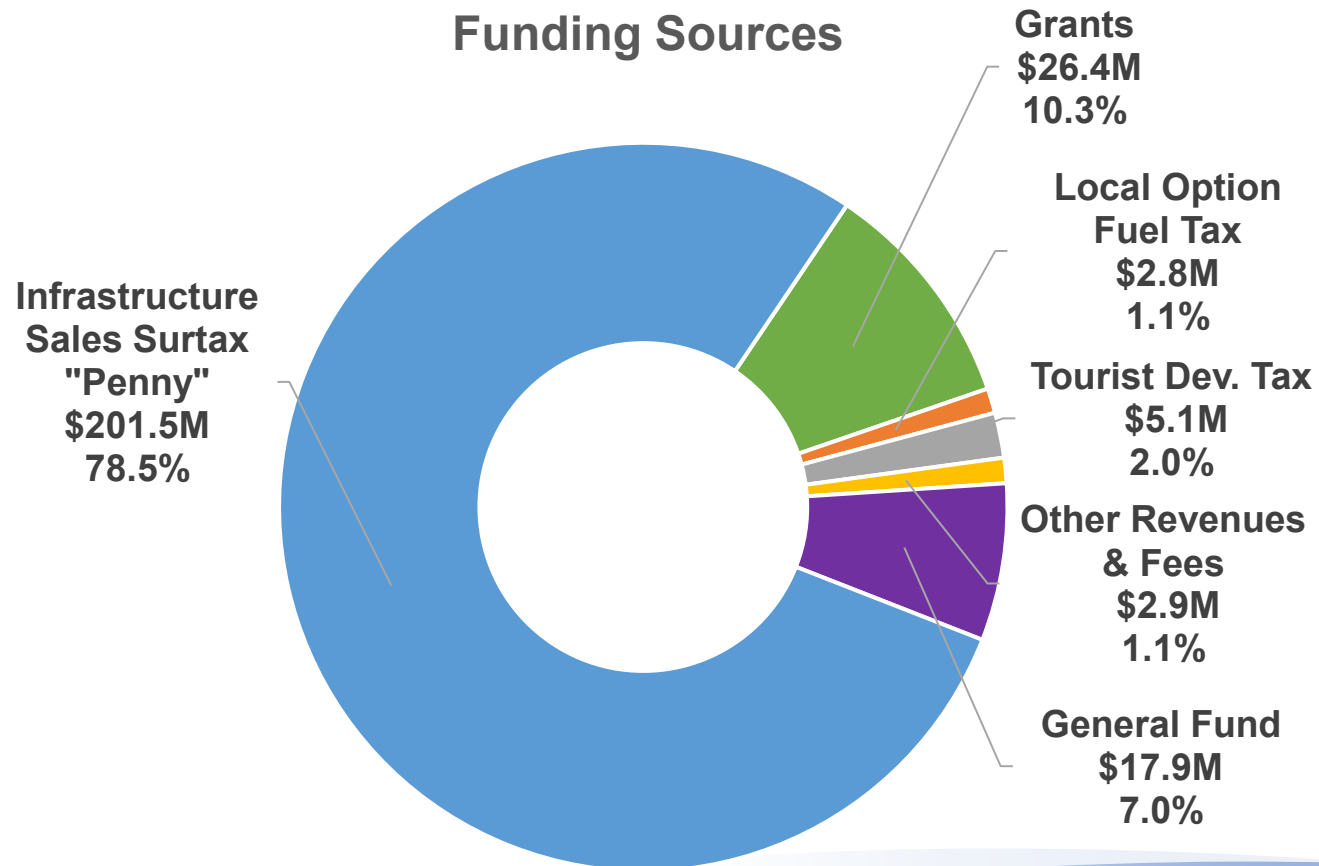
- Economic Development Capital Projects & Housing 8.3%

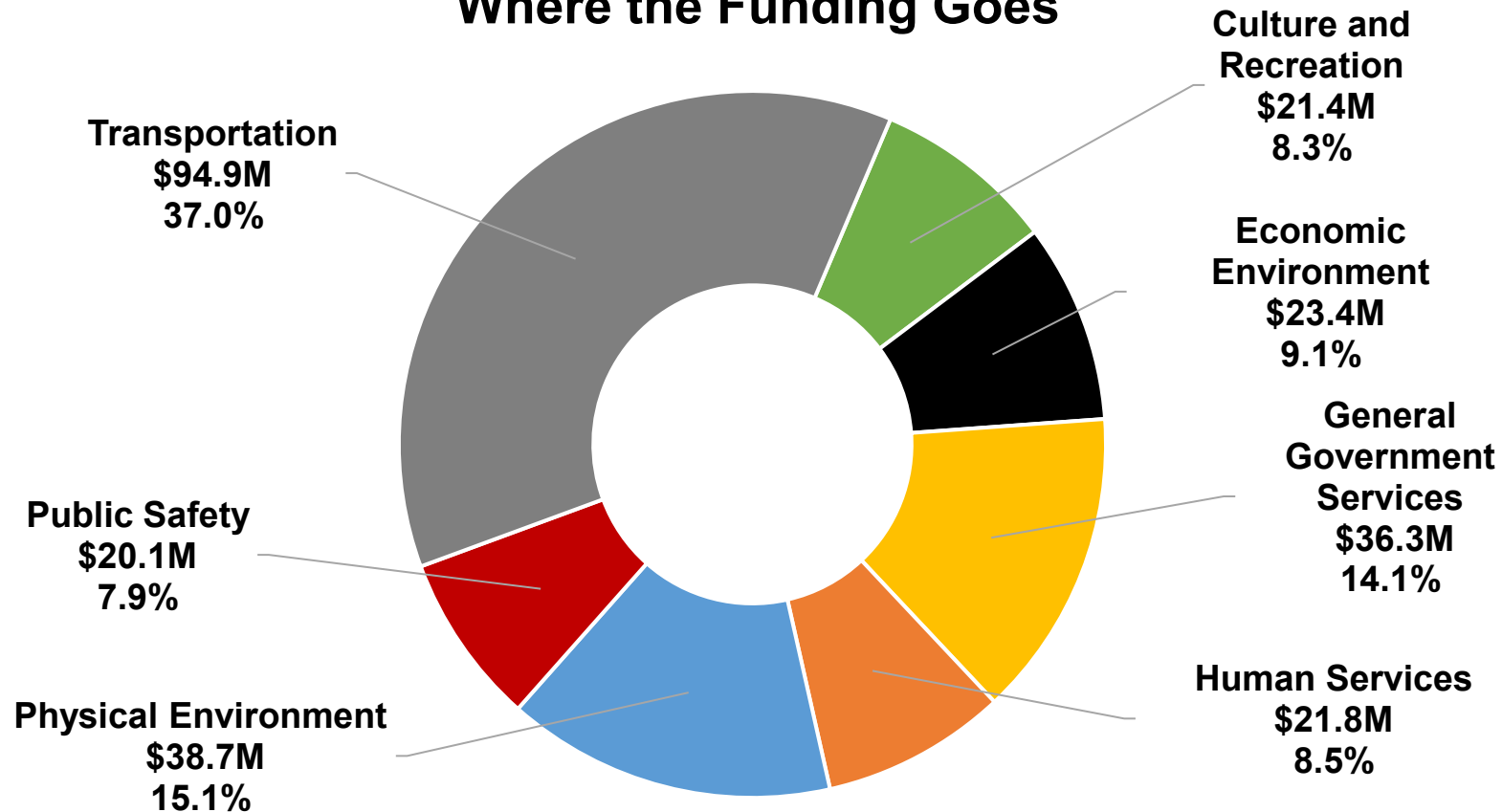
FY23 Proposed Budget – Capital Fund \$256.6M

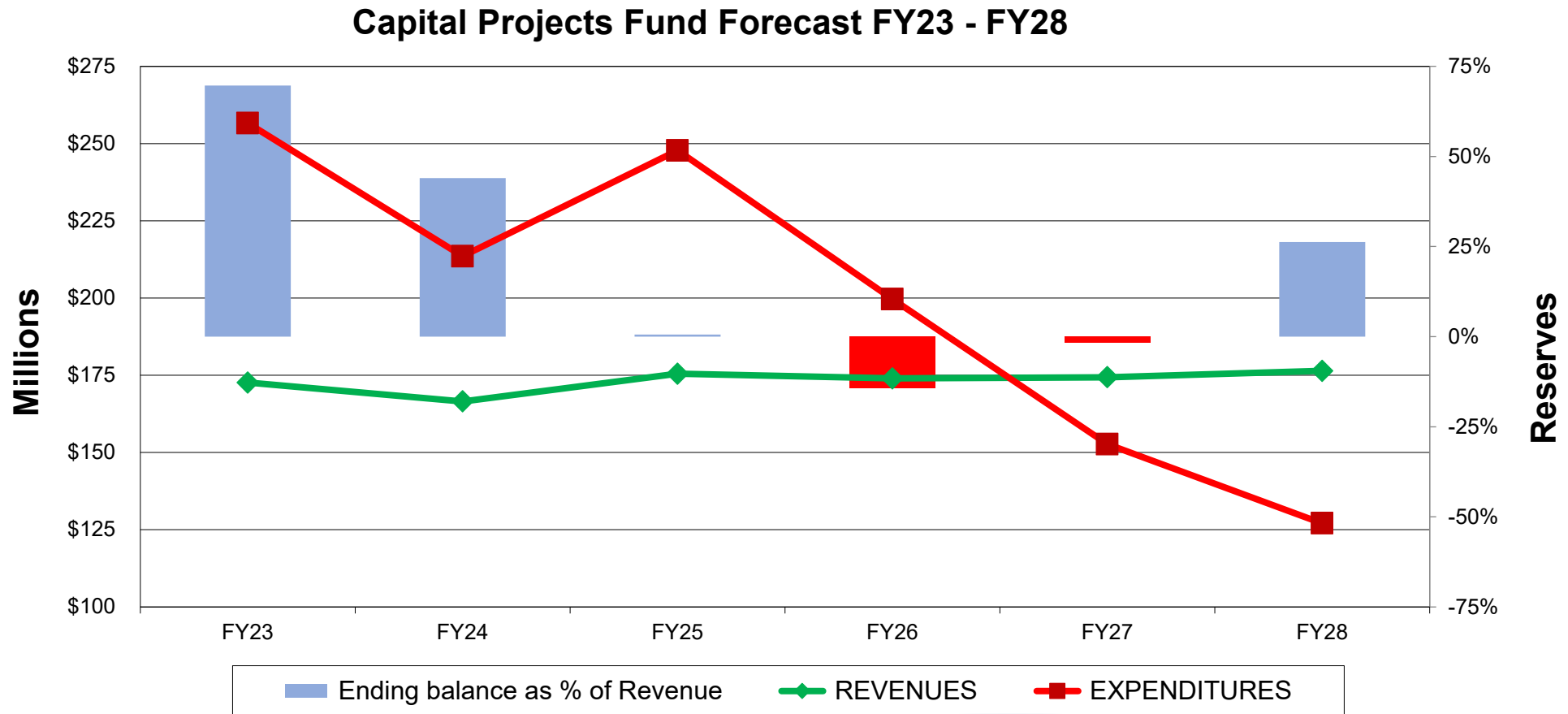
