## NOTICE OF PUBLIC HEARING FOR PROPOSED ADOPTION OF A NON-AD VALOREM ASSESSMENT ROLL IN ACCORDANCE WITH THE STATE UNIFORM NON-AD VALOREM COLLECTION METHOD

The Pinellas County (the "County") Board of County Commissioners (the "Board") is holding a public hearing (the "Hearing") to consider adoption of a resolution (the "Resolution") adopting a non-ad valorem assessment roll pursuant to the State Uniform Non-Ad Valorem Collection Method (the "Uniform Method") prescribed by F.S. §§ 197.3632, 197.3635. Adoption of said roll will levy a special assessment (the "Assessment") on Parcel I.D. Numbers' 29-29-16-38602-000-0090 and 29-29-16-38602-000-0100, which are respectively located at 1836 and 1860 Oak Street, Clearwater FL, 33760 (the "Assessed Properties"). A map of the Assessed Properties—the boundaries of the real property subject to the Assessment—is included at the bottom of this notice. The Resolution and Hearing satisfy the requirements of F.S. § 197.3632(4)(a)1. The Hearing will be held on Tuesday, July 19, 2022, at 6:00 P.M. in the Board Assembly Room at 315 Court Street, 5th Floor, Clearwater, Florida 33756.

Pursuant to F.S. § 197.3632(3)(a), the Board adopted Resolution No. 21-114 at a public hearing on October 12, 2021, stating its intent to use the Uniform Method to levy the Assessment. The Assessment is required to fund 100% of costs for dredging the Hidden Cove II Oak Street (Stormwater) Retention Area, which is owned by the Assessed Properties (the "Project"). The Project was completed on March 28, 2022, at a total actual cost of \$29,654.71. The Project has improved the storage capacity of the Retention Area, thereby improving water quality and decreasing flooding. The value of the Assessed Properties should also increase as a result of the Project. Thus, assessing the Assessed Properties for 100% of the total actual Project cost is fair, equitable, and legally justified. The Resolution proposes to apportion (levy) the Assessment equally to each Assessed Property over a period of ten (10) years beginning in Tax Year 2022; therefore, each Assessed Property will be assessed \$1,482.74 per year, unless an Assessed Property opts to prepay its entire share (\$14,827.36) pursuant to F.S. § 197.3632(8)(b). It follows that the total revenue that the Board will collect from the Assessment is \$29,654.71, which is the total actual Project cost. Consistent with the Uniform Method, the Assessment will be collected by the Tax Collector on the annual Tax Bill; failure to pay the Assessment will cause a tax certificate to be issued against the Assessed Property, which may result in a loss of title. All affected property owners have the right to appear at the Hearing and the right to file written objections within twenty (20) days of the publication of this notice.
