Proposed Abstract (Project Scope of Work): The purpose of the project is to design a shared-use path within the project limits that closes a shared use path gap from the Duke Energy Trailhead located west of US 19 to Eagle Lake Park, located along Keene Road. The purpose of the project also includes evaluation and design of appropriate multimodal safety features, including pedestrian refuge medians, crosswalks, a stabilized shoulder, and left or right turn lanes (where needed) within the project limits. Old growth oaks currently line Belleair Road between Havana Drive and the Pinellas Trail. The proposed improvements need to avoid widening the asphalt in this area to avoid impacts to the existing old growth trees.

Benefit Summary (How will this benefit the County, Dept, etc?): This project will benefit non motorized persons by filling in the shared use path gaps and adding midblock crosswalks; and will benefit motorized persons by reducing crash possibilities with stabilized shoulders and turn lanes.
