Added material bins to the baseball/softball fields utilizing MSTU monies

Enhanced our temporary fencing at Sunderman Complex

Repaired fencing at Sunderman Complex

Resurfaced tennis courts

Added four pickleball courts outdoors

Upgraded all pickleball court nets

Added Clay to our softball fields

Overseeded our athletic fields

Hired a professional landscape company to maintain fields and landscaping.

Added another two feet to our downtown Christmas tree, and ornamentally added to it.

Changed out all light switches to be on a motion sensor.

Repair flooring in the hall bathroom

A/C at both Harbor Hall and The White Chapel have been replaced under our new agreements with the County.

Replaced exterior bathroom doors at our outdoor bathrooms and outfitted them with programmable locks .

Added security cameras to Pop Stansel Park.

FINANCIAL

Staff continues to be very vigilant with expenditures and saves at every crossroad. This year was no exception. Programing returned with a vengeance from the impacts of covid. Program revenue is our largest self-earned revenue stream. We are thankful and blessed for certain. We did however see a 2nd consecutive year that our Rental Revenue line was down. Covid impacted us significantly in our 2nd largest self-earned revenue line, and still ran down 20% in FY22. However due to an 31% increase in program revenue our income surpassed our budgeted amount by over 90K. As a result of a decade of hard work, we have been able to capitalize monies out of operations each fiscal year and are excited about the opportunity to build a permanent 2500 sq ft building to utilize during construction of our Community Center and continue on for decades to house programming. We started learning how to do more with less during the economic downturn of 2007 and continued to be conservative with tax dollars to get to this successful point of our organization.

Offer free ice cream with socialization for community

Alzheimer support group meet here at the Hall weekly, and we provide space for their literature

Several girl scout groups meet weekly

Partner with Pinellas County School Board to provide space for several groups to utilize Parks and Recreation Space.
