## RESOLUTION NO. 23-10

RESOLUTION OF OF THE BOARD COUNTY COMMISSIONERS OF PINELLAS COUNTY. FLORIDA. INDICATING THE BOARD OF COUNTY COMMISSIONERS' SUPPORT OF THE FLORIDA **DEPARTMENT** TRANSPORTATION TO LIGHT THE BOB **GRAHAM** SUNSHINE SKYWAY BRIDGE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Bob Graham Sunshine Skyway Bridge (Skyway Bridge) is a part of the State and federal highway system that spans Tampa Bay, with its northern terminus located in Pinellas County, its southern terminus located in Manatee County, and a portion of the bridge also located within Hillsborough County; and

WHEREAS, the bridge is an asset of the Florida Department of Transportation (FDOT), which can be lit in a manner to recognize or commemorate federal or state holidays and events of broad community interest or significance; and

WHEREAS, while FDOT reserves the right to decide bridge lighting displays, it is the policy of FDOT to seek and obtain the approval of local governments within which bridges are located prior to lighting the bridge; and

WHEREAS, FDOT routinely seeks the approval of Pinellas County accomplished by resolution of support by the Board of County Commissioners (Board); and

WHEREAS, formal action of the Board, including adoption of resolutions, cannot be accomplished outside of a properly noticed meeting that complies with Florida's sunshine laws.
