A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA VACATING A PORTION OF OLD ROOSEVELT BOULEVARD AND 35<sup>TH</sup> STREET NORTH IN SECTION 3-30-16, PINELLAS COUNTY, FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Pinellas County ("County") seeks to vacate before the Board of County Commissioners ("Board") the following described property:

Lands described in the legal description in Exhibit A, attached hereto and by this reference made a part hereof; and

WHEREAS, the County has shown that the vacation of such portions of the plat will not affect the ownership or right of convenient access of persons owning other parts of the subdivision; and

WHEREAS, the Board finds that the portions of the platted right-of-way that are the subject of this Resolution no longer serve a public purpose and are a proper subject for vacation pursuant to Section 336.09, Florida Statutes.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida that:

- The above-described property and plat depicted in Exhibit A shall be vacated, insofar as this Board has the authority to do so pursuant to Section 336.09, Florida Statutes.
- To the extent that the vacated area overlaps with any other public easement or right-of-way
  created by deed, plat, petition, maintenance, or otherwise, the subject vacation shall have
  no effect thereon.
- 3. The Clerk shall record this Resolution in the Public Records of Pinellas County, Florida.
