## NOTICE OF PUBLIC HEARING PROPOSED ORDINANCE AMENDING THE PINELLAS COUNTY CODE

The Pinellas County Board of County Commissioners proposes to amend the Pinellas County Code by Ordinance.

A public hearing on the Ordinance will be held on Tuesday, August 15, 2023, at 6:00 P.M. in the County Commission Assembly Room, Fifth Floor, Pinellas County Courthouse, 315 Court Street, Clearwater, Florida 33756.

Interested parties may appear at the hearing and be heard regarding the proposed Ordinance.

1. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:

AN ORDINANCE OF THE COUNTY OF PINELLAS, PROVIDING THAT THE PINELLAS COUNTY CODE BE AMENDED BY REVISING **CHAPTER 122 OF SAID CODE: PROVIDING** FOR REVISIONS TO CHAPTER 122 ADDING CLARIFYING LANGUAGE AND ADJUSTING DEFINED TERMS; AMENDING SECTION 122-40 RELATING TO MAINTENANCE OF RECORDS AND TOWING AGREEMENTS; AMENDING SECTION 122-42 ESTABLISHING TOWING RATES AND ADJUSTING VARIOUS FEES; PROVIDING FOR SEVERABILITY; PROVIDING FOR AREAS EMBRACED; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR AN EFFECTIVE DATE.
