Hope this finds you well. After talking with Tim Burns last week. Mike & I have spoken & there are 3 issues with what needs to be addressed that have been discussed with PCCP & not addressed, same issues 4 years ago.

- 1) Dollie Fee for the specialized equipment required for the proper towing of 85% of current vehicles either because they are AWD (All Wheel Drive) or the cars can't be towed with axels on the ground, being parking garages are not accessible to Flatbeds & create even another issue. Dollies Cost about \$2500, a rim & tire replacement assembly \$250 Plus X 4, regular maintenance & are required equipment.
- 2) Gate Fee's a reasonable fee for after regular hour releases 6pm to 8am Monday- Friday & weekends when staff are called out to release after posted regular business hours. The fee is authorized in other counties in Florida,
- 3) CPI, we asked for this 4 years ago as it works great in other counties every year unless there is something that would be out of the realm of ordinary circumstances. The perfect example of failure is the current ordinance, it was supposed to be updated & in place a year ago. We provided PCCP a year ago what they are finally proposing at the meeting,

I would like you to see these & if needed we can talk with Brian about our thoughts. Also want to send these on to all
our commissioners & PCCP so know one is blind sided at the meeting on our issues.

I would appreciate your thoughts & input on this.
