The purpose of my this email is to be formally counted in registering that I am 100% opposed to the proposed FY2024 Pinellas County budget.

Instead of passing it, you should cut, cut, and then cut some more. Briefly, my opposition is based on the following:

1/ Either you believe the official federal government inflation numbers...or you don't.

If you believe the official US BLS inflation numbers, then it follows that we now have extractive and oppressive government in Pinellas County. I say that because the size and scope of Pinellas County government has grown exponentially since 1950, and since 2010, and since Barry Burton arrived on the scene.

+ In 2020, <u>Burton tried to usurp authority that belongs to the BCC</u> - in doing so, he exposed the county to legal risk...yet I didn't hear any of you who were on the commission at the time (Long, Justice, Eggers and Peters) ask any questions about Burton's attempted usurpation. Maybe you didn't see what Burton was doing? If you didn't, please start seeing through and calling out the garbage you are being fed by Burton and others.

The then commissioners were fed an "out of an abundance of caution" story that was a lie. If you don't start calling staff on such garbage, people will think you *want* it this way because you are dumb or statist or both. I know that many of your aren't either, so please push back when you are fed garbage explanations and garbage narratives.

- + The county lied to small businesses during COVID about their responsibilities under the county's Safer at Home order was Burton behind these lies being told to small businesses in Pinellas County?
