Dear Pinellas County Commissioner,

I am writing this mail as a resident of Palm Harbor. I want to let you know how important the library services have been to my family.

My niece is 15 years old is a volunteer on the Youth Advisory Board of the Library. She loves books and reading and this position is a perfect fit. She is on the autism spectrum and has struggled with learning disorders, particularly reading. She has come through many emotional and behavioral challenges thanks to her own and her parents' perseverance, supportive members of the community and many other resources. To see her taking on a volunteer role doing something she loves is something I could not have imagined even a few years ago. Her ability to access books at the library has kept her off electronic devices (which were causing behavioral issues).

As a mental health professional and owner of Anxiety Center of Tampa, I experience first-hand the damage that too much screen time and social media use cause to our children and adolescents. There is a huge increase in depression and anxiety among young people, and much of it can be related to excessive use of devices.

My fear, not just for my own niece, but for all the children in Pinellas County, is that if the proposed budget cuts are made to the library and other programs, this will result in significantly less access to resources that have been a gamechanger for so many, like my niece.

Please, please reconsider this proposal. I believe that, like me, most Pinellas County taxpayers would be willing to pay \$1 per month to contribute to the health and well-being of our children.

Dear Commissioner Eggers,

Thank you for the support at last week's BOCC meeting when the issue of a proposed reduction in the millage rate was brought to the floor. As you well know, a few dollars' increase in a homeowner's trim notice translates to tens of thousands of dollars in revenue losses for our libraries and recreation departments in unincorporated north county. This also holds true for the PPLC millage rate which, if reduced, has the greatest impact on Palm Harbor Library and East Lake Community Library, since these allocations, unlike the municipal libraries in the county, go directly into our operational budget. We are STILL trying to offset the removal of overdue fines several years ago, which further reduced our revenue income. Our population growth, increased costs for goods, utilities, staffing, etc., and the need for continued programs and services puts a strain on the existing funding we receive. Our estimated losses from both a reduction to our millage rate and that of PPLC would be over \$110,000, which would have a crippling effect on this library and community. We always continue to seek other sources of funding to help provide the services that our public expects and deserves. Reducing funding will not help anyone. It will have a negative impact on most. Thank you for your consideration of this matter.

Dear Pinellas County Commissioners:

I saw in our local library the motion to cut the millage only to Palm Harbor Community Services Agency and entities which obviously includes our libraries. I would imagine there is no easy path when a decision has to be made to modify budgets. It may be further complicated when the public does not know how the decision came about to ONLY burden Palm Harbor Community Services rather than more equitably spreading the measures evenly through Pinellas County as a whole.

The Pinellas County web page as of July 20, 2022 commended the commissioners on the 2023 budget, "Conservative fiscal practices and new growth have allowed the County to meet key budgetary goals of strengthening access to behavioral health...and creating a cultural plan that coordinates investments into the arts." What changed this mindset in 2023?

When is the last time you walked into a library? I have to admit, I have lived here more than 3 years and have watched my tax properties increase and not taken advantage of some of the county services; however, today that changed. My daughter and I walked into the East Lake Library and walked out with a new library card each, my daughter an armful of books, and me with resources to share with my aging congregation.

Since covid, it has been difficult for many of our seniors to feel safe to reconnect and they are craving connection. The East Lake Library offers a service to bring books to neighbors who cannot make it to the library. They have resources to share where free grief groups are available, community classes and well-care events and free access to participating museums. This library, like others, has a plethora of classes for children, teens and adults. What a beautiful way to make connections. Oh and let's not forget books and movies in the library.

When we close resources for the mind and well-being of the community, what volumes does that speak to us as civic leaders? Where are our priorities?

For where your treasure is, there your heart will be also. Matthew 6:21

We are all public servants and I believe we would be remiss in our duties to not pause and see who we are affecting with our decisions. When hard decisions have to be made, could not the burden be shared?

According to REDFIN, as of July 2023, Palm Harbor home prices were up almost 16% compared to last year with a median sales price of \$475K. 132 homes sold this July. I watch the houses go for sale in my neighborhood with an average days-on-market of less than 30 days. Rocket Homes reports a 10% increase in home values in Palm Harbor from 2023 as compared to 2022, the largest change when compared to Dunedin and Tarpon Springs which had single digit increases; Oldsmar and Clearwater had a slight decrease in sales.

Each home sale means additional income for the county coffers. Each increase in the sales prices means an increase in the county coffers. And yet Palm Harbor is the only city being penalized with a dramatic cut to its services. That does not make sense to me.

I would request that you be mindful of these difficult decisions and possibly reconsider a more equitable distribution of budgeting matters. It matters to each community.

When the children's section has a Pokemon display, he is in heaven! Every time we go, he asks for coins to put in the donation container at the front.

For me, this library is a place I can always find the book I'm looking for, or request it be transferred from another branch. I'm a Girl Scout Service Unit Cookie person, and I've used the library space so many times when meeting with individual troop cookie parents to train them on computer aspects of cookie season. The staff never turned me away, never told me I was doing anything wrong and created a haven for one who needed it.

Palm Harbor Parks and Rec has also been an amazing space. I attend various programs there, they let friends host activities for children of all abilities, and host so many Girl Scout events!!

These two organizations not only deserve all the money they requested, but in reality they deserve more! 

Respectfully, if the proposed cuts are approved at next week's public hearing, the East Lake Community Library alone would lose approximately \$110,000 from this year's budget while East Lake Recreation would lose approximately \$73,000. This would have a crippling effect on programs and services.

This cannot be a logical solution as the millage rate reduction would mean an average of less than \$1/month from homeowner's trim notices but would have a huge negative impact on our libraries and recreation.

Families all over the county rely heavily on the services provided by their local library and the cost of these cuts to the community would be so much greater than can be measured on paper. We are all for fiscal responsibility however, we urge you to seriously reconsider if this is the way to achieve it.

Dear Members of the Board of County Commissioners.

I reside at 5913 Windermere Drive in Palm Harbor and serve as Chair of the East Lake Community Library (ELCL) Advisory Board. I am writing to you on behalf of the ELCL Advisory Board and as an anxious citizen.

As you prepare to finalize the FY2024 budget for Pinellas County next Tuesday, I strongly urge you to follow the guidance of County Administrator Barry Burton and preserve the tentative millage rates for the authorities/MSTUs serving unincorporated North County: East Lake Library Services (.2500), East Lake Recreation Services (.2500), and Palm Harbor Community Services (.5000).

I applaud the BCC for taking a very close look at the budget and considering the impacts to our costs of living here, especially as it pertains to extraordinary pressures of inflation and insurance in recent years. I assure you that these same issues are being felt at the East Lake Community Library, along with the challenge of providing competitive salaries in the job market without the additional health and retirement benefits afforded to County employees. It forces creativity and strong partnerships to develop an environment where services are maximized at minimal cost. Every dollar matters.

As a Pinellas County taxpayer, the BCC's efforts to determine millage rates that effectively prevent taxing "too much" by factoring in our rising property values is appreciated. However, Commissioner Peters said it best at your Regular Meeting on September 7, 2023, "I know we [BCC] all want to save the taxpayers some money, but I don't think this is significant enough... This is pennies on somebody's tax bill for the savings that we would incur." I fully agree. The likely \$2-12 annual savings barely covers the cost of gas or a Publix sub, but it has demonstrable impact at scale when it adds up to almost 10% of the ELCL annual operating budget. And it is the same with our friends at East Lake Recreation and Palm Harbor Community Services.

Additionally, the Public Library Services District funds the Pinellas Public Library Cooperative (PPLC), the interagency across all libraries within our County. Though they may be best known as a way to share books across our 20+ libraries through the Reciprocal Borrowing Agreement, the PPLC provides significant scale for shared media and online services, leveraged by *all* Pinellas libraries. Further, PPLC distributes funding to each of the libraries and, for those libraries in unincorporated

Pinellas, this has an outsized impact as these funds go <u>directly to library services</u>. It is critical that the Public Library Services District funds are secured at their tentative millage rate of .5000 by BCC on September 19.

Commissioners, without a city infrastructure in Palm Harbor you truly are our only local government representatives. Your ardent support for the services provided to the citizens of unincorporated North County is encouraged and appreciated. As Chairman of the ELCL Advisory Board, and as a resident and beneficiary of the services in this area, I ask you to keep the millage rates intact for the East Lake, Palm Harbor, and Library Services districts for FY2024.

Dear Members of the Board of County Commissioners,

The Friends of East Lake Community Library exist to "promote and enhance library services and facilities of ELCL, to foster closer relationships between the library and its community, and to raise funds in support of the library, its materials and resources." We raise funds to support the library, but our funds cannot in any way replace the tax dollars that assure quality library service in East Lake.

As you prepare to finalize the FY2024 budget for Pinellas County next Tuesday, we strongly urge you to preserve the .2500 millage rate for the East Lake Community Library. We also urge you to continue to maintain support for the Pinellas Public Library Cooperative. The Cooperative services and materials available and used by the East Lake Community Library are invaluable.

While we appreciate the BCC examining tax rate given the rising costs of living, inflation, and insurance, it is true that the same costs are being felt at the East Lake Community Library. In addition, the library faces the challenge of providing competitive salaries in the job market without the additional health and retirement benefits afforded to County employees (library employees are not county employees.)

We agree that Commissioner Peters said it best at your Regular Meeting on September 7, 2023, "I know we [BCC] all want to save the taxpayers some money, but I don't think this is significant enough... This is pennies on somebody's tax bill for the savings that we would incur." The likely \$2-12 annual savings makes little difference to a homeowner's budget but could have a very large impact on the library because it amounts to almost 10% of the library's annual operating budget.

The Pinellas Public Library Cooperative – better known as PPLC – plays a critical role as an interagency across all libraries within our County. They enable sharing books across the county's 20+ libraries through the Reciprocal Borrowing Agreement, and also provide shared media, online databases as well as the shared catalog of library holdings. Further, PPLC distributes funding to each of the libraries and, for those libraries in unincorporated Pinellas, this has an outsized impact as these funds go directly to library services. It is critical that PPLC funds are secured at their millage rate of .5000 by BCC on September 19.

We appreciate your past support for the services provided to the citizens of unincorporated North County. The Friends of East Lake Community Library ask you to keep the millage rates intact for the East Lake Community Library in FY 2024.

Since my retirement and relocation to Florida from NY (in late 2015), I have utilized its many offerings multiple time per week every year. I also frequently utilize the inter library loan system, which makes this library the complete package for me and so many others. Dear Commissioners: I recently learned that a proposal exists to reduce the millage rate for the Palm Harbor and East Lake entities as well as the Pinellas Public Library Cooperative, which funds many of the countywide services to ALL libraries, including e-resources, Deaf Literacy, and Talking Books. If these proposed cuts are approved at Tuesday's public hearing, the East Lake Community Library would lose approximately \$110,000 from this year's budget while East Lake Recreation would lose approximately \$73,000. This would have a crippling effect on hours, staffing, programs, and services. The millage rate reduction would only mean an average of less than \$1 a month from homeowner's trim notices but would have a huge negative impact to our library and recreation.

These are vital services that many in our community rely on for intellectual development, social interaction, and a myriad of services that benefit and enrich our area. As our community representatives, I ask you to not cut these services but find other ways to identify needed funds that do not impact community enrichment.
