Human Services is requesting the approval and execution by the Board of County Commissioners (Board) of an Agreement with Directions for Mental Health, Inc. d/b/a Directions for Living, Two (2) Renewals and Amendment (Renewals) with Operation Par, Inc., (Operation Par), Westcare Gulfcoast-Florida, Inc. (WestCare) for the Cooperative Agreement to Benefit Homeless Individuals (CABHI).

- These Renewals and Agreement will continue funding of CABHI. The CABHI program provides supplemental field-based co-occurring behavioral health treatment to housed residents that have experienced being unhoused and have a behavioral health diagnosis. CABHI staff bring services to the client to reduce barriers in maintaining stabilizing behavioral health care.
- · An Agreement with Directions is being processed to document negotiated staffing changes, a 5% cost of living increase, and updates standard boiler plate contract terms.
- This is a two (2) year renewal, effective October 1, 2023. The current agreement has been in effect since October 1, 2020, and is expired on September 30, 2023.
- · Original agreements were approved on September 22, 2020, file #20-1223A. Amendments with Operation PAR and WestCare were approved on February 20, 2023, file #22-1342D to implement a 5.0% cost of living adjustment increase

Annual funding in an amount not to exceed \$735,310.00 has been identified in the fiscal year 2024 (FY24) Human Services Approved Budget.
