Description & Comments

The Department of Administrative Services' (DAS) Facilities and Real Property Division (FRP) has requested the adoption of a resolution to declare a County-owned property located at 4017 56th Avenue North, Saint Petersburg, Florida (Property) as surplus, the approval and execution of a Purchase and Sale Agreement (Agreement) to sell the Property to Florida Dream Center, Inc. (FDC), and approval of the Declaration of Restrictions. It also requests the Chair or Vice Chair take all necessary actions to close the sale of the Property in accordance with Florida Statutes 125.38 and recommends that the Chairperson sign and the Clerk of the Court attest and record the resolution in the Public Records of Pinellas County.

County staff have recommended selling the Property at the market value of \$1,195,000.00, as determined by a licensed appraiser. This revenue was not budgeted for in the FY24 Adopted Budget and will be received by the Capital Fund (Penny for Pinellas/Fund 3001) for Project 001071A (Affordable Housing Land Assembly Program) in the amount of \$1,195,000.00 as unanticipated revenue. No additional budgetary action is necessary if approved, as this will only add unanticipated revenue in FY24. Additional budgetary action would only need to be taken if the County wished to recognize this unanticipated revenue and increase expenditures, which would require a budget amendment (resolution) and public hearing for approval. Otherwise, revenues will be higher than what was budgeted in FY24, which will impact the FY25 fund balance.
