WHEREAS, the Florida Dream Center Inc. (FDC), a Florida not for profit corporation, desires to purchase the Property at a sale price of \$1,195,000.00 for the purposes of promoting community interest and welfare.

NOW, THEREFORE, BE IT RESOLVED by this Board of County Commissioners of Pinellas County, Florida, in regular session duly assembled on this _____ day of _____ 2023, as follows:
