## THIRD AMENDMENT

This Amendment made and entered into this <u>31st</u> day of <u>October</u>, 20<u>23</u> by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and SHI International Corp, Somerset, NJ hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

## WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on November 9, 2021, pursuant to Pinellas County Contract No. 21-0201-PB (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Information Technology Solutions & Services for County; and

WHEREAS, Section 37 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an increase to the total contract expenditure, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- Section 8 ("Compensation and Method of Payment"), subsection b, is revised to reflect an increase in the amount of one million, one hundred thousand dollars and zero cents (\$1,100,000.00) for a revised not to exceed sum of eight million, six hundred thousand dollars and zero cents (\$8,600,000.00).
- For clarification purposes, this is the Third Amendment to the contract, but only the Second Amendment to the Agreement with SHI International Corp. specifically.
- Except as changed or modified herein, all provisions and conditions of the original
  Agreement and any amendments thereto shall remain in full force and effect.
