FIRST AMENDMENT

This Amendment made and entered into this _____ day of ______, 2024, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Patterson Veterinary Supply, INC hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on AUGUST 01, 2023, pursuant to Pinellas County Contract No. 23-0518-ITB (hereinafter "Agreement") which the Contractor agreed to provide for the installation of new kennels for Animal Services for County; and

WHEREAS, Section 36 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an increase to the total not-to-exceed amount, with the same terms and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. Section 14 (Compensation and Method of Payment), subsection B (Spending Cap and Payment Structure) is revised to reflect an increase in the amount of two hundred fifty-three thousand, nine hundred eighty-eight dollars and thirty-two cents (\$253,988.32) for a revised not to exceed sum of one million one hundred seventy-eight thousand, four hundred sixty and seventy-three cents (\$1,178,460.73).
- Exhibit C Payment Schedule is hereby deleted in its entirety and replaced with Exhibit C
 Payment Schedule Revised, attached hereto.
- 3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
