Staffing, including key management vacancies	Since our Service Area Competition submission in September 2022, the health center has had two significant key management changes. The Health Center Project Director (CEO) changed from Dr. Joshua Barnett to Dr. MaryEllen Dennis. Dr. Dennis has an extensive background working in health care administration in both the public and private sector. At the December 2022 HCH Co-Applicant Board meeting, the Board reviewed Dr. Dennis's resume and experience and unanimously accepted the County's recommendation to appoint her to the Project Director role. A prior approval was submitted and approved in January 2023. The Chief Medical Officer, Dr. Chitra Ravindra, retired in November 2022 and was replaced by Dr. Patrick Agdamag. Unfortunately, Dr. Agdamag left the position in July 2023 and the search for a new CMO continues. The CMO is a position contracted through the Florida Department of Health in Pinellas County to serve the Health Care for the Homeless Program.			
Operations, including changes in policies and procedures	There have been no significant changes to policy and procedures in the last 12 months. The health center has made progress towards increasing its unduplicated patient count post-Covid by implementing Street Medicine and taking health care to unhoused homeless in Pinellas County. The health center also established telehealth access points for homeless, who don't own personal technology to conduct virtual visits with their health care provider. Operations have been impacted by 1) construction/temporary relocation of services; 2) Hurricane Idalia; and 3)			

MMU mechanical failures. The health center closed the Bayside Health Clinic in July for 3 days
to move to its temporary site during the construction period and 3 days due to Hurricane Idalia.
In CY23, the MMU experienced mechanical breakdowns resulting in 40 days out of service.
