Authorize settlement authority up to \$285,636.67 to settle the cases of Leighanna Staley v. Pinellas County and Barbara J. Hetrick v. Pinellas County, Florida.

Summary:

On July 13, 2017, Plaintiffs were driving at or near 54th Avenue, S. and 50th Street, S. in St Petersburg when Ms. Hetrick's vehicle was struck by a County vehicle driven by a former County employee. The impact of the accident caused Ms. Hetrick's vehicle to strike the vehicle in front of her, belonging to Ms. Staley. Both Plaintiffs were injured as a result of the accident.

Risk previously paid compensation in this matter totaling \$14,363.33, which leaves \$285,636.67 remaining within the County's sovereign immunity cap. Ms. Hetrick incurred medical bills in excess of \$157,000.00 for treatment her physicians attribute to the accident. Ms. Staley incurred medical bills totaling \$72,133.57.

Plaintiffs have negotiated amongst themselves and have proposed settlement within the remainder of the sovereign immunity cap to resolve all claims they have against the County, as well as the remaining subrogation claim of Ms. Hetrick's insurance company.

It is recommended that settlement authority be granted up to \$285,636.67 to resolve these matters. Risk Management and County Administration concur with this recommendation.
