In 2015 the Timmons Group submitted on RFP No. 134-0001-P (RG) — Computer Software Consulting: Enterprise Asset Management (EAM) System. Through a competitive process our team along with Azteca Systems was selected as the implementer and software vendor for the County's Enterprise Asset Management Solution. Our scope met all the technical requirements in the RFP with a fee of just over \$3.2M total cost. In the Contract Negotiations Cancelation letter dated September 25, 2015 the reason for cancelation is that our team was not the right "fit" for the County though we met, through a competitive process, the technical requirements to complete the project.

Following are the points our team would like to make:

- Timmons Group total fee that met all requirements of the RFP was \$3.2M. This fee included services for upfront planning, data migration from legacy systems, integration with other core business systems, and the implementation of the Cityworks software. The fee submitted as part of the June 21st agenda by Woolpert, Inc. is over \$5M and does not include many of the key elements of the original RFP including data migration, system integrations and most importantly Cityworks software implementation. The average Woolpert Inc. rate is over \$200 per hour while the submitted blended rate for Timmons Group was \$135 per hour.
- The Timmons Group team went through an extensive competitive selection process which included submission of a
 proposal and an all-day short list presentation. It was determined by the County that our team met the technical
 requirements of the RFP. Woolpert, Inc. did not submit on the RFP and did not participate in the competitive
 selection process
- The Timmons Group Team (including Jones Edmunds (JEA), and GIS inc.) are all Cityworks Business
