Overall, I am satisfied with Mr. Bennett's performance, especially as it relates to keeping us apprised of major issues facing the county. I continue to have a good working relationship with some of his attorneys and would continue encouraging Mr. Bennett to pursue training for them and to have an opportunity to work on weaknesses or said better to continue to develop more fully as attorneys.

He seems to have a good handle on the legalese of issues and would continue to encourage him to be more assertive with other employees at the highest level of leadership in the county.

My biggest disappointment is that we haven't brought forward the separation of quasi-judicial zoning portion of the cases from the legislative land use portion of the cases. There is a clear division of arguments in either case along with the latitudes the Commission has in making decisions. I certainly hope this mixed approach does not put this County at risk in future cases where Commission arguments are misinterpreted as quasi-judicial when, in fact, the comments are more appropriate for the legislative portions.

In any event, I have also challenged Mr. Bennett to be contemplating succession planning as it relates to internal candidates and their accelerated need for development.
