

Julie Ward Bujalski, Mayor

Julie Ward Bujalski was elected to the Dunedin City Commission in April 2006, served two appointed terms as Vice Mayor, and was elected Mayor in November 2014.

Julie comes from generations of family who have lived in Dunedin since the 1950's, where they owned a downtown business, served in civic organizations, worked in law enforcement and volunteered for the betterment of their community.

Growing up in Dunedin, Julie attended Ms. Honald's Dunedin Day School, Dunedin Elementary, Dunedin Highland Middle and Dunedin High School. She went on to study business at ITT Technical Institute and Fashion Merchandising at St. Petersburg College.
