

## FIFTH AMENDMENT

This Amendment made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2016, by and between PINELLAS COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "County," and Miles Partnership, LLLP (f/k/a Miles Media Group, LLLP), Sarasota FL hereinafter referred to as "Contractor,"

### WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on January 15, 2013, pursuant to Pinellas County Contract No. 112-0250-P (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Technology Marketing Services for County; and

WHEREAS, Section Sixteen (16) of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a name change from Miles Media Group, LLLP to Miles Partnership, LLLP and a three (3) month time extension at the same prices, terms, and conditions;

NOW THEREFORE, the parties agree that the Agreement is amended as follows:

1. The Contractor's name is changed from Miles Media Group, LLLP to Miles Partnership, LLLP.
2. The term of the Agreement is hereby extended beginning October 1, 2016 and continuing through December 31, 2016.
3. The not-to-exceed compensation amount for the October 1, 2016 through December 31, 2016 term is \$375,000.00
4. By virtue of the name change, Miles Partnership, LLLP agrees to assume all obligations and liabilities of the Agreement.
5. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Agreement represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Agreement; (ii) each person executing this Agreement on behalf of the Party is authorized to do so; (iii) this Agreement constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.
