## RESOLUTION CLARIFYING JURISDICTION OVER SIDEWALKS ADJACENT TO **COUNTY ROADS**

WHEREAS, numerous roads within the County were transferred from the State of Florida to Pinellas County for jurisdiction and maintenance through functional reclassification pursuant to Sec. 335.04, Florida Statutes, 1978; and

WHEREAS, pursuant to that statute, as reconfirmed by Sec. 335.0415, Florida Statutes, 1995, the area transferred included only the portion of the road between the curbs and specifically excluded sidewalks: and

WHEREAS, doubt has been expressed by some municipalities as to their responsibility for those sidewalks adjacent to County roads that cross through and into municipalities; and

WHEREAS, attempts to define and divide responsibility between some municipalities and the County through interlocal agreements has been unsuccessful; and

WHEREAS, it is desirable to clarify the responsibility of the County as to these sidewalks,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida, in regular meeting duly assembled this 19thday of December, 2000, that Pinellas County has no jurisdiction or responsibility for maintenance over those sidewalks within municipalities which existed alongside County roads transferred from the State of Florida pursuant to functional reclassification; and

BE IT FURTHER RESOLVED that nothing in this resolution is intended to or shall have the effect of changing the responsibility which Pinellas County has over sidewalks adjacent to all other County roads, or those sidewalks which it has built subsequent to the transfer referenced above; and

BE IT FURTHER RESOLVED that nothing in this resolution is intended to or shall have any effect over sidewalks that have in the past, or may in the future be the subject of interlocal agreements between the municipalities and the County.
