#### **BOCC PINELLAS December 13, 2016**

In 1801, the Danbury Baptist Association gave notice to Thomas Jefferson in a letter titled "The Wall of Separation".

In this letter, "The Wall of Separation", The Danbury Baptists Association accuses Thomas Jefferson; (stating) "if those, (if ye) who seek after power and gain under the pretence of government & religion, should reproach their fellow men....as an enemy of religion, he will not assume the prerogative, he dares not to make laws to govern the Kingdom of Christ.

The Danbury Baptist Association warns Thomas Jefferson of a "sincere" pre-determined opposition (of theirs) against those who wish to rise to wealth and importance on the poverty and subjection of the people, stating that "Religion is to be considered the first object of legislation".

Important Instructions and Information > RECLAMMED WATER FACILITY (NOT UTILITY)

Pinellas County may grant a variance from the terms of Pinellas County Code 82-3, County Reclaimed Water Shortage Conservation Measures, when such variance will not be contrary to the public interest and where owing to special conditions, a literal enforcement of the provisions of the ordinance would result in hardship, irrigation system limitations, religious convictions or the health and safety of the applicant

Written application for a variance shall be submitted to the Pinellas County Utilities Conservation Department.

The application for variance shall demonstrate that:

The variance shall not be in conflict with any other applicable ordinance or state law

The variance will not adversely affect the reclaimed water supply

The variance will not violate the general spirit and intent of the ordinance nor will it be inconsistent with the County Comprehensive Plan

Pinellas County shall consider a variance from the County Reclaimed Water Shortage Conservation Measures as soon as possible after submittal of the written application.

FEE (SIMPLE) ORDINANCE 97-103 SECTIONS

In granting any variance, Pinellas County may prescribe appropriate conditions and safeguards to assure conformance. STATUTE EMINENT. DOMAIN



A Baptist elder in Connecticut, Nehemiah Dodge began his career in the ministry in Hampton in 1788 before moving on to Southington. He published many tracts and orations and fought for disestablishment. About 1820, upon becoming a Universalist, he served as pastor of the Universalist Church in New London: Stephen S. Nelson was a graduate of Rhode Island College and moved from Hartford to Mt. Pleasant, New York, in 1801 to become principal of an academy (William G. McLoughlin, New England Dissent 1630-1833: The Baptists and the Separation of Church and State, 2 vols. [Cambridge, Mass., 1971], 2:930, 987, 1008).

OUR COLLECTIVE CAPACITY: the Danbury Baptist Association was organized in 1790 and consisted of twenty-six churches, mostly in western Connecticut, but including three churches in eastern New York. At its October 1800 meeting, the association initiated a petition movement to redress the grievances of the dissenting minority against the Congregationalist majority in OF THE STATE
